- If you prefer to opt with the 'Old Tax Regime', you can opt for claiming few components in your salary structure as reimbursements and you will also be required to submit the investment declaration along with supporting documents for the year 2024-25.

You are required to please exercise your option of choosing the tax regime and submit your tax declaration with proof latest by, Monday 18<sup>th</sup> November, 2024. Otherwise calculations will be made under New Tax Regime and tax will be deducted accordingly.
