#### **ABOUT THE COLLEGE**



SLC is a premier educational institution offering vibrant inclusive environment for the development of excellence in academics, culture, sports and other student empowered activities. Founded in 1964 by the great visionary and entrepreneur Padmashree (late) Shri Shyam Lal Gupta, Shyam Lal College (SLC) is a co-educational constituent college of the University of Delhi. SLC is among the best institutions in the entire University of Delhi, and over the past several years, has been making steady progress towards achieving academic excellence. SLC is a dynamic centre of academic excellence and aspires to make quality education accessible to the students, especially girls, from economically and educationally disadvantaged community of East Delhi. The College campus has sprawling sports ground and is full of lush green lawns and blooming gardens that create natural ambience of holistic teaching learning process. Over a period of 56 years, SLC has evolved into a leading higher education institute of learning, innovation and knowledge creation with consistent good NIRF ranking for Colleges of India - 69th (2020), 41st (2019) and 61st (2018). The College has also been selected for DBT STAR College Programme under the Ministry of Science and Technology in 2020.

The College has rapidly emerged as a prominent educational institution of the Country and the Hon'ble Vice-President of India Shri Venkaiah Naidu has graced our Annual Day and Prize Distribution function, 2018-19. The endeavor of the College has always been to make higher education more committed, joboriented, meaningful and pragmatic, and at the same time more adaptable to the ever-changing demands of our society and globe. The College has taken several innovative initiatives towards creating a culture of innovation amongst students. SLC established Innovation Council (IC) under MoE's Innovation Cell, an initiative launched in November of 2018. SLC's Innovation Council works towards inculcating the spirit of innovation among students, and develop a start-up ecosystem. The Skill Development Centre of the College offers many value course and Certificate and Diploma courses in German, Spanish, French, Chinese, Japanese, Korean (Affiliated to Department of Germanic and Romanic Studies, University of Delhi) as well as Certificate course in stock trading "Mastering the Stock Market" in collaboration with BSE Institute Ltd. The College also offered value added courses on Yoga and Holistic Development, Research Analytics, Introduction to Artificial Intelligence and Introduction to Bitcoin and Blockchain Technology, Virtual Introduction and Digital Marketing. SLC is a participating institute in the Unnat Bharat Abhiyan (UBA 2.0) which is the flagship programme of MoE, GoI. Under this project, SLC has adopted 5 villages - Dhitora (Baghpat), Nithora (Ghaziabad), Chirodi (Ghaziabad), Jawli (Ghaziabad), Kotwalpur (Ghaziabad) to support rural development through institutional linkages. The Unnat Bharat Abhiyan team comprises of faculty members and student members of SLC who have conducted extensive surveys of the said villages, participated in campaign, conducted workshops and interacted with villagers. SLC has achieved another remarkable milestone with Ministry of Education recognizing SLC as SAP (Swachhta Action Plan) institution in 2020.

The College is fully equipped with state-of-the-art Computer labs, Science labs, Knowledge Resource Centre and Library, Sports facilities to upgrade knowledge, skills and capabilities of the students needed to groom them as future leaders. Lot of many new additions in the infrastructure set-up is underway for the benefit of students. At SLC, we encourage our students to become responsible citizens with critical thinking and analytical abilities, thereby contributing to the development of healthy environment and a society free from any kind of discrimination and bias. Our objective is to nourish, nurture and promote holistic higher education, providing equal opportunity to all.

#### Mission

#### Connectivity

The College is well-connected by the Metro Rail network and road. The flyover network from Welcome Metro Station to ISBT will connect SLC to North Campus, Delhi University with travelling time of 10 minutes. The Metro Stations of Welcome and Shahdara which fall on the Rithala-Shaheed Sthal (New Bus Adda) Metro route via Kashmiri Gate are both at a walking distance from the College and provide the fastest and most convenient mode of transportation from most parts of the city and neighbouring towns of NCR. In addition, the College is well-connected by road and bus services to various parts of the city. The famous Grand Trunk Road (G.T. Road) runs just adjacent to the College and connects it to the neighbouring towns of U.P. such as Sahibabad and Ghaziabad as well. The Inter State Bus Terminal (ISBT) at Kashmiri Gate and ISBT at Anand Vihar are not more than 5 kms away from the College. The Anand Vihar railway station provides very good direct connectivity to the College for students coming from eastern parts of the country.



#### **SOCIAL ROLE**

SLC makes all efforts to fulfill its institutional and social responsibilities towards all its stakeholders and the community. Through collaboration with community organizations, industry partners and civic groups, SLC constantly strives to find innovative solutions to societal issues. With the aim to correct gender inequality, the College offers 1% concession in marks at the time of admission to the girl students. The College is also committed to making a contribution in eliminating the prevailing inequality in NCR region through imparting wholesome higher education to all. In practice, the College has been correcting this imbalance at the grass-root level, with its geographical proximity to the most backward



localities of Delhi. Time and again, through its various units like NCC, NSS, Gandhi Study Circle, Ambedkar Study Circle and Eco-Club, the College has initiated social welfare activities and created possibilities for equitable social development. The College has completely renovated its old building with the installation of two lifts, six brand new washrooms and a new reception desk that make it a fully differently-abled friendly area. The lush green gardens in and around the campus have completely changed the landscape of the College. In the academic year 2015-16, the College added an entire new building - the Porta Block to its existing infrastructure. This building has state-of-the-art infrastructure including CCTV surveillance system and a seater dedicated Conference Hall, Board Room, Teacher's Facilitation Centre with up-to-date ICT facilities. The Staff Room, Library, Office and Cafeteria have been recently renovated into fine air-conditioned spaces. The College has successfully implemented fully functional CCTV



Surveillance system in and outside the campus. This ensures adequate safety and security to our students. The entire SLC campus is now a Wi-Fi zone with internet access available to each and every student and faculty members of the College. #### NEP 2020: A New Paradigm to Empower India National Student Seminar

The Unnat Bharat Abhiyaan(UBA) and Internal Quality Assurance Cell (IQAC) of SLC in collaboration with Shiksha Sanskriti Utthan Nyas (SSUN) organized a National Student Seminar on "National Education Policy (NEP) 2020 – A New Paradigm to Empower India". The seminar was conducted on February 16, 2021 in the College Seminar Hall with participants physically present in the College (including faculty and students) and a huge no. of participants joined on virtual platform Zoom and Facebook. The Seminar comprised of an Inaugural Session, one Plenary Session



and three Parallel Sessions with students' paper presentations. The seminar was inaugurated by Shri. Atul Kothari Ji (National Secretary, Shiksha Sanskriti Utthan Nyas) with Prof. P.C. Joshi (Acting Vice Chancellor, University of Delhi) as the Guest of Honour and Prof. Balaram Pani (Dean of Colleges, University of Delhi), Prof. V.K. The Seminar was intended to focus on NEP 2020 to build an intellectual, socially aware, informed and skilled nation that can inspire the people so as to make the country self-reliant and reclaim the position of Vishwa Guru. The Seminar offered an opportunity to all the stakeholders to come forward and interact with experts and make suggestions. The students' participation was overwhelming and over fifty papers were received from all over the country. Students from Assam, Kerala, Tamil Nadu, Punjab, Uttrakhand, Manipur, Haryana, Uttar Pradesh, etc. zealously presented their views and presentations. - A five days long "Hands On Scientific Software Training Program" was organized in collaboration with IQAC for students from 22nd 26th February, 2021. The participants were given training on different scientific software like Chem Draw, Origin, Hyper Chem, etc. which are an integral part of research.
- A week long Inter College "Hand On Capacity Building Training Workshop For Non-Teaching Staff" was organized in collaboration with IQAC during 2nd to 8th March 2021. This training program was also held physically in our computer lab and chemistry lab. The participants were given hands on training on the preparation of solutions and calibrations of various scientific instruments.

#### **ACADEMIC INNOVATIONS**

SLC took the pioneering initiative, in the year 2015-16, by starting the Public lecture series under which the College has already organized many Virtual lectures with global experts through SKYPE software, which turned out to be very helpful for us to switch over to Covid induced online teaching & learning.

#### Academic Innovations during Covid-19 Pandemic

SLC has taken several academically innovative initiatives during the current Covid-19 pandemic situation. The faculty members at SLC are dedicated to their work and are actively engaged in providing necessary support to the students in the Covid-19 pandemic times and the subsequent lockdown. The College faculty members are using following ways and platforms to engage with students towards continuing teaching-learning process:

- Popularizing the Virtual Lab for the benefits of the students.
- Students' engagements through Live Projects.
- Multi-Disciplinary Idea Generation Competitions among students.
- Co-Creation, Co-Sharing of knowledge and dissemination by engaging experts from different fields etc.
- Uploading e-resources on college website for student perusal.
- The students access e-resources uploaded by their teachers.
- Engagement of student classes through online platforms like Google Meet and Google Classroom. Teachers engage the students throughout via Zoom, Webex, Skype etc. for innovative, deliberations, competitions and meaningful mentoring.
- The online class sessions are recorded and sent to students who are unable to join the same.
- The faculty members also use Google classrooms to upload PDF files and videos and solve student queries using Chat room options.
- Teachers have used Google forms for taking tests, projects and assignments.
- The College has made available online reading material to all the students through N-list portal for which all students have been given login and password.
- The College has also provided link on the college website for the reading material made available by the Delhi University library system and SOL.
- The incumbent holds weekly meetings with the TICs via virtual platforms during the Covid-19 for monitoring the smooth functioning of the teaching-learning process and other academic and administrative matters.
- > The College also started a helpline for students to help in data recharge of the mobile phones of those students who could not afford data recharge and were, thus, unable to attend online classes and complete assignments.
- The College has also organized series of Webinars and online discussions on various topics of contemporary relevance.
- The College has reached out to the students who have lost their parents during the severe Covid- 19 second wave in April 2021 by initiating a project Anutosh. College has provided immediate counselling from professional counsellor, mentored them towards a safe and professionally secure future and also helping them in academic and other needs.

#### **Interdisciplinary Student Projects and Student Development Programmes**

#### **GUIDELINES FOR ADD-ON COURSES:**

- 1. Admission on First come First Serve Basis.
- 2. For Certificate Courses in Stock Trading minimum eligibility is 10+2. Certificate Course in mastering the Stock Market (30 hrs.) can be pursued with any language course.
- 3. For Certificate Course in Foreign Languages(German/Spanish/French/Chinese/Japanese/Korean)
- a) Minimum eligibility is 10+2 with 45% aggregate.
- b) Ex-Students who have passed from B.Com (Hons.), B.Com (Prog.) and B.A. (Hons), Economics & B.A.(Hons.) English in 2020 from University of Delhi are also eligible. (Subject to maximum of three years of passing out.)
- c) Employees of University of Delhi and other recognized Universities are also eligible.
- 4. For Diploma in German/Spanish/French/ Chinese/Japanese/Korean: Candidates who have passed the Certificate Examination of the University of Delhi in a language or an examination recognized as equivalent thereto are eligible to apply for admission to the Diploma Course in that language. Admissions will be made strictly in order of merit of the respective certificate course examination. Candidates who have obtained their Certificate in the language from any other institution OR one year or more before the year of admission shall be required to appear in an admission test. The fee for the entrance test will be ₹. 500/-

- 5. For Diploma in French/German/Spanish/ Japanese/Chinese/Korean: Candidates who have passed the Diploma Examination of the University of Delhi in a language or an examination recognized as equivalent thereto are eligible to apply for admission to the Advance Diploma Course in that language. Candidates who have obtained their Certificate in the language from any other institution OR one year or more before the year of admission shall be required to appear in an entrance test. The fee for the entrance test will be ₹. 500/-.
- 6. An amount of ₹. 1000 will be deducted if admission is cancelled within one week of commencement of classes. Beyond one week of commencement of classes there will be NO refund of fees.
- 7. Minimum number of students in each batch of language courses: 20 Minimum number of students in each batch of stock market courses: 30 (Commencement of a course is subject to admission of minimum number of students in it.)
- 8. Maximum number of students in each batch of all courses: 50

#### VALUE ADDED COURSES

In addition to these certificate & Diploma courses. SLC also offered value added courses on Yoga and Holistic Development, Research Analytics, Digital Marketing. Introduction to Artificial Intelligence and Introduction to Bitcoin and Blockchain Technology.

#### **EXTENSION ACTIVITIES**

During the course of the year, SLC organized several extension activities such as those for the benefit of students belonging to the under-privileged sections of society, or those meant to celebrate important events in the calendar of the nation. In addition to this, remedial classes are organized under the aegis of IQAC of the College for students from less privileged sections. Department of English, under the guidance of the Principal Prof. Rabi Narayan Kar, started Spoken English Course for the students of the College in the year 2016-17 which has now become a regular feature of the academic activities in the college. The course is primarily meant for those students who face difficulties and are unable to acquire English language skills properly. The Course runs successfully every semester on six or four week basis where the students are given course completion certificates.

Students need a mentor not only in the classroom but also outside it. In continuation of its endeavour to ensure holistic development of the students, the College has initiated the Mentorship Programme. All the faculty members have been assigned students from different streams so as to ensure a multi-disciplinary learning experience for the students. The Programme shall allow the students to give vent to their ideas and seek valuable advice from their Mentors regarding their academics as well as career and overall development.

#### **INTERNAL QUALITY ASSURANCE CELL (IQAC)**

As per National Assessment and Accreditation Council (NAAC) guidelines every accredited institution should establish an Internal Quality Assurance Cell (IQAC) as a post-accreditation quality sustenance measure. Since quality enhancement is a continuous process, the IQAC becomes a part of the institution's system and works towards realization of the goals of quality enhancement and



sustenance. The prime task of the IQAC is to develop a system for conscious, consistent and catalytic improvement in the overall performance of institutions. IQAC led by Prof. Kusha Tiwari continuously undertakes numerous activities like FDPs, SDP, workshops, National conferences, symposium, and remedial

classes for the overall development of the students. **CENTERS** 

The College, in its effort to maximize the teaching learning outcome, has established Seven important centers that offer a unique platform and opportunity to students to have a wholesome learning experience. The important events organized and initiatives taken by these centers have evidently opened the minds of students to newer ways of thinking. These centers have taken up cross-cutting issues related to modern lifestyle, gender, caste identity in India, professional challenges, social anomalies etc.

#### **Centre for Industry Interaction (CII)**

The Centre for Industry Interaction (CII) has been set up to promote interaction as well as collaboration of SLC with industry for mutual benefit. The Centre was conceived with the objective of imparting a better understanding of the needs of industry among our students. There is also an effort, in future, to draw up agreements, MoU's with companies to help the College develop students' skills in line with industry requirements and take more skill development initiatives. The Centre works towards organizing seminars and workshops to guide students on emerging career options, and to improve skills of the students for greater success in group discussions and personal interviews, and to invite experts from industry as well as academia to address the employability aspects of the differently-abled students of the College in terms of their special skill development needs, and to



promote their placement, wherever possible, along with other students. It operates through its 2 constituent cells, viz. Training and Placement Cell, and Entrepreneurship Cell.

#### **Training and Placement Cell**

With its motto "Drive towards corporate", SLC Training and Placement Cell is committed to provide placement assistance to the students of all courses. In addition to holding on-campus recruitment drives, it also regularly undertakes numerous training programmes, workshops, and Industry-Academia interactions, for the jobseeking students. This year also, in addition to its regular events, the cell successfully organised its 2nd Annual Job/Internship Fair COMPITO' 2021 in online mode on 16th & 17th March, 2021. The students were



interviewed for diverse profiles ranging from business development, fashion consultant to marketing and sales. Through its various initiatives, the cell is fully devoted to help every SLCian become a global leader who can manage and lead change across diverse organizations. SLC is also member of Internshala through which hundreds of students are benefited with internships.

#### **E-Cell**

Founded with the aim to foster and sustain the spirit of entrepreneurship amongst the students, the E-Cell, since in its inception has majestically expanded and successfully mentored many budding entrepreneurs. The cell is committed to support next generation entrepreneurs who would contribute to the economic and



social development of the nation. In addition to holding workshops for young entrepreneurs, the cell regularly undertakes numerous training programmes, talks and organise various events like Business plan, Hackethons, Case Catalyst, Stakeholders Meet, Bulls v/s Bears Run, Think-Tank and alike to promote entrepreneurial spirit amongst the students.

#### Centre for Skill Development (CSD)

College organizes several skill development and soft skill enhancement programmes in the College that fulfill the aim of the Institution to impart skill-based integrated education. The Foreign Language Courses are conducted under the aegis of Department of Germanic and Romance Studies, University of Delhi and the Department of East Asian Studies, University of Delhi.

#### Women Development Centre (WDC)

SLC, in its efforts to sensitize the students and the faculty towards gender equality and harmony, brought Women Development Cell (WDC) into existence. Since its inception WDC has taken up crosscutting issues related to professional challenges and social anomalies. Through its various initiatives, WDC has

In line with is mission, WDC & IQAC, SLC (University of Delhi) in collaboration with Indian Council of Social Science Research (ICSSR) organized an International Conference on "Through a (New) Looking Glass: Challenges for Women in the 21st Century" on 9th & 10th January, 2020 at Indian Society for International Law (ISIL) and Seminar Hall, SLC respectively. WDC also organized National Webinars on "Mental Health and Well-being in Present Times" on 26th September, 2020 and on "Challenges for Women during Covid 19 Pandemic" on 7th November, 2020.

#### Classrooms

There is a Knowledge Resource Centre in the Library where students and teachers can acquire abundant knowledge through e- resources by accessing world's best databases, E-Journals, E-books and reports in an easy and expeditious manner. The College proudly announces that it has constructed a state-of-the-art Reading Room with a seating capacity of 75. The library also has an important designated facility for the PwD students of the College in the form of PwD Facilitation Centre which has dedicated computer systems with all the relevant software installed so as to facilitate the smooth imparting of education to PwD students.

#### **Conference Centre & Multi-Purpose Hall**

#### **Board Room and Teacher Facilitation Centre**

#### Medical Facility

The College has a dedicated medical room. A physician visits the college thrice a week. The students may also avail the W.U.S. (World University Service) Health Centre facility in B.R Ambedkar College.

#### **Computer Centre**

The College has four computer laboratories and a dedicated Knowledge Resource Centre. SLC boasts of state-of-the-art computer centers equipped with servers, printers, desktops, laptops, LCD projectors and scanners of latest configuration. Additionally two new computer labs well-equipped with modern amenities are expected to be functional very soon. All the operations in the college library as well as administrative office are automated. The Computer Labs of the College offer the very best in terms of hardware and software resources to the students and the faculty.



#### **Science Laboratories**

SLC strives to provide the best of facilities to its students with various science and computer laboratories. The Physics, Chemistry and Electronics labs with the very best equipment and efficient support services offer ideal conditions to science students to carry out their practical work. The Botany Lab was set up just a few years back in the college and is being rapidly brought up to the level of its other science labs. These science and computer labs provide an ideal environment to students for academic excellence, and for faculty to maintain the high standards that they have attained.



#### **Girls Common Room**

SLC very much recognizes the need for exclusive private spaces for its students, in view of the fact that students have to spend several hours in the College, not all of it needs to be inside the classroom. This makes the Girls Common Room an important area of the College. Equipped with very good recreational facilities, the GCR has recently been refurnished. The GCR Committee of the college took the pioneer step to install a Sanitary Napkin Vending machine in the GCR with the collaboration of CSR Research Foundation.

#### **Security Arrangements**

Located in the heart of East Delhi and with all major means of transportation available right in front, the College has the great advantage of being located at a completely safe and secure part of the city. The fact that the Shahdara Police Station is situated just adjacent to the College further enhances this sense of security. Further, the posting of police officers very close to the College premises imparts a sense of safety and security to the students travelling to and from the institution. Within the premises, the College tries to instill values of respect and mutual trust among all sections of the College in which everyone can work without fear and suspicion towards the



achievement of his/her goals. Nevertheless, the College does not take security within the premises for granted, and keeps its infrastructure and human resources operating at all times to detect any security breaches.

#### **BEST PRACTICES**

#### SAP (Swachhta Action Plan) Under MoE

SLC has achieved another remarkable milestone with Ministry of Education recognizing SLC as SAP (Swachhta Action Plan) institution in 2020. Under this scheme, SLC has undertaken to work towards essential swachhta activities including sanitation and hygiene, waste management, water management, energy management and greenery. To achieve the above tasks, the College has formed committees that are actively charting out plans to work in the defined areas for maximum benefit of the institution and its stakeholders.

#### **Student Mentoring Programme**

SLC has successfully implemented mentorship programme through IQAC of the College, for all the students. Under this full fledged mentorship programme, all the students are assigned to designated faculty members during their stay in the college.

#### Assessment and Feedback

The College has also successfully implemented the structured holistic feedback system that ensures that the concerns of the students are heard and addressed. So far, we have successfully completed three cycles of taking feedback from the students that have been analyzed and the raised issues have also been addressed and rectified.

#### **Community Outreach Programme**

SLC is actively sensitive to its Institutional Social Responsibility and promotes institution- neighbourhood - community initiatives and outreach programs through its various activities that broadly fall under NCC/NSS/WDC/EOC/Sports. SLC is surrounded by many underdeveloped, overpopulated and minority community localities, and so becomes the sole facilitator, in the area, of achieving academic excellence for

students belonging to economically backward classes and minority communities. SLC has also adopted Shahdara mandi and regularly conducts cleanliness drives.

- The College is located in an area of the city densely populated by under-privileged sections of society. SLC's policy of giving preference to the girl students in the Admissions is largely aimed at correcting the gender bias/disparity in the neighbourhood and community.
- SLC is the foremost College in East Delhi Campus of the University of Delhi with outstanding Sports facilities. The College promotes sports and games in the trans-Yamuna region of Delhi by providing opportunities and best coaching facilities to the young and talented players from low-income groups or underprivileged sections of society.
- The College has conducted various surveys in the past, including the survey as part of the Innovative project 'Old Age Homes in Delhi Understanding the Challenges Faced by Them and Their Contribution to the Society'. The primary objective of this project is to have a closer view at the old age homes functioning in Delhi in order to assess the problems and challenges that these institutions are facing.
- The College has tie-ups with several NGOs to work for the community. NSS volunteers of the College visit slum areas and spread awareness about cleanliness in collaboration with NGOs.
- The tree plantation activities organized by the College are aimed at improving the air quality in and around the College, as well as for creating awareness about protection of environment.
- Most of the activities of the Equal Opportunities Cell such as remedial classes and Spoken English classes for students from under-privileged communities and facilities for differently abled also largely benefit the students from surrounding areas.
- The College participates in all national initiatives aimed at promoting good citizenship such as cleanliness drive, skill and entrepreneurship development initiatives, "Make in India" campaign, etc. The College has set up Centre for Skill Development following the launch of this programme by the Union Government.
- Under the aegis of WDC and ICC, the College regularly organizes workshops, lectures, sensitization programmes, counselling sessions, film screenings and live performances on gender issues and discrimination.
- SLC has also adopted Shahdara mandi and has conducted cleanliness drives, switch over to cashless trading and plastic free campaigns.
- SLC has adopted 5 villages under UBA project under MoE, GOI. The team has conducted extensive surveys of the said villages, participated in the Swachata hi Sewa campaign, interacted with villagers and other stakeholders of the villages. The team has also worked with and helped the adopted villages during COVID-19 pandemic in following ways: poster and video distribution about maintaining hygiene and sanitation, distribution of food packets, distribution of groeries, distribution of masks, dissemination of information through Whatsapp groups to farmers regarding precautions to be taken in farming activities during the pandemic etc.
- The NSS of the College also regularly organizes "Nirbheek" One week Women self-defense camp for girl students.
- The UBA team and NSS team of the College has already conducted cleanliness drives in Yamuna Bazaar Ghat no 21. The Development and Maintenance of Ghat No.-21 has been done along with repairing, beautification, restructuring, painting and colouring work.
- The students at SLC are taught the importance of participating in community service and contributing to help all the sections of society specially deprived and underprivileged. The NSS wing of the College lives up to its motto "Love All and Serve All". The students engaged with NSS volunteer with a number of NGOs. They also organize clothes donation drives to support NGOs like Amar Jyoti. The NSS, every

year, organizes a blood donation camp in the College. NCC girls of SLC have participated and organized Self- defense Camp, Yoga Camp, Tree Plantation drive and save Yamuna Campaign'. The NSS of the College has also worked on an in-house project of restoration of Yamuna Ghats. The UBA team and NSS team of the College has already conducted cleanliness drives in Yamuna Bazaar Ghat no 21. The Development and Maintenance of Ghat No.-21 has been done along with repairing, beautification, restructuring, painting and colouring work.

- The College has NCC, NSS, Women Development Cell, Centre for Holistic Development, Centre for Industry Interaction and Skill Development, Ambedkar Study Circle, Gandhi Study Circle etc. which organize events dedicated towards community service like blood donation camp, tree plantation drive, Save Yamuna Campaign, gender sensitization, identity discourses, moral education etc. to enhance the sense of community feeling and citizenship among the students.
- The Enactus team of the College has worked on community outreach projects like "PRAYOJYA" (2018). The project is an effort to reduce plastic pollutants in our surrounding by transforming them from waste plastic bottles to useful and decorative plastic utensils and simultaneously providing employment to women from underprivileged communities and train them in the art of making different kinds of decorative stuff with plastic.

#### Institutional Social Responsibility Initiatives

- The College actively supports and observes government advisories issued about preventive measures, for Covid-19 pandemic, like hand hygiene, social distancing, cough etiquette are circulated among the staff, students, surrounding neighbourhood and in adopted villages from time to time.
- A WhatsApp group with members from the adopted villages, under UBA, like the Pradhans, village elders and officials has been formed so as to spread awareness about hygiene and sanitation among as many households as possible.
- The students of the College have been making handmade soap and masks to distribute them in their neighbourhood so as to help people maintain good hygiene and fight Covid-19 pandemic.
- ➢ NSS volunteers have also taken care of abandoned pets and stray animals; they feed them on every day basis in their neighbourhoods.
- The College is actively involved in food distribution among the poor and the homeless. NSS students of the college also regularly distribute ration to the needy people in slum areas.
- Student members also make handmade masks and distribute them to vegetable vendors, slum dwellers and many others in their neighbourhood.
- The UBA team and NSS team of the College conducts cleanliness drives in Yamuna Bazaar Ghat no 21. The Development and Maintenance of Ghat No.-21 has been done along with repairing, beautification, restructuring, painting and colouring work.
- SLC students academically help the students in villages and slums through virtual modes.

#### Mental Well-being Initiatives

- > The Head of the institution regularly meets and interacts with students via virtual platform in order to resolve their queries regarding uncertainty of the academic session due to the pandemic situation.
- Counselling Cell has been activated with Mobile no. of professional counsellor and doctor to address students' anxiety and other issues.
- The college also regularly organizes counselling sessions for students through ICC, WDC and Placement Cell.
- The Principal follows the open door policy and is always available to students during office hours.

- > The College has a very active mentoring mechanism in which teachers mentor and regularly meet their mentee (students) in order to resolve their academic and other concerns.
- During the Covid-19 pandemic, the college also facilitated the mobile data recharge of students' phones so that they do not miss out on interactions and classes with teachers.

#### Powered by Renewable Energy

The Solar Power plant of the College is fully functional and generates power covering 45% of our peak demand. The Solar Power plant, installed in the college, is a collaborative initiative with IPGCL, Govt. of NCT of Delhi wherein the said govt. agency has borne the full cost of the installation of the Solar panels in the college. We have been saving power as well as financial resources since the plant became fully functional. The College also practices regular switch off drives so as to save and conserve energy.



#### **Other Green Initiatives**

Conservation of environment has been the focus of College. The students and faculty members of the College work in coordination to cultivate and preserve a green environment.

- The college is a tobacco-free, smoke-free zone and has said a loud 'NO' to crackers and plastic bags.
- The College takes special care to inculcate the habit of switching off fans and lights when these are not in use.
- All garden waste is used for making compost in compost pits.
- Burning of garden waste is strictly prohibited on the Campus to minimize air pollution.
- E-waste is routed through appropriate channels for proper disposal.
- In order to ensure safe drinking water, the College has installed ROs in the campus.
- College also engages in tree plantation in and around the campus.
- Renewable energy in the college is also an important focus area.
- College made efforts for carbon neutrality, with large green-patches, gardens, and a vast collection of trees.
- College has installed three LED screens to communicate with students and faculty to reduce the use of paper in printing official notices etc.
- The College is increasingly shifting to the use of LED lights.
- E-waste generated in the campus is managed as per the E-Waste Management through a committee. The E-waste is disposed off to authorized recyclers.
- The Garden Committee attempts to ensure the use of natural fertilizers and natural material for supporting plants and climbers.

#### **Rain Water Harvesting**

As the institution is committed to zero water wastage and harnessing, the power of every drop of this precious commodity, SLC has taken important measure like rain water harvesting system.

#### **Recycling Papers**

SLC is sensitive towards the cause of conserving natural resources and promotes the culture of respecting nature. SLC, in collaboration with NGO Jaagruti, has started recycling of waste papers and in return has received numerous reams of paper.

#### LED Lights

The usage of LED lights has reduced the power consumption heavily. The installation of LED lights following the installation of solar panels has helped the College to save its financial resources. In addition to it, switch-off drills are carried on regular basis to make the SLCians aware and alert regarding energy consumption and saving.

#### Sewerage Treatment Plant

The college has sewerage treatment plant of capacity 75000 L under construction which will be fully operational very soon.

## Opportunities for neighbourhood under-privileged School children to participate/coaching facility for different games

SLC aims at promotion and improvement of sports and games in trans-Yamuna region of Delhi by providing opportunities and best coaching facilities to the young and talented players of the society. The endeavor is to provide a platform to young talented players with state-of-the-art amenities so that they learn, train and improve their standard in sports and games, and excel at the international and national level. For the purpose, the college has taking a new initiative to provide free and regular coaching in the above mentioned games to deserving and talented students from neighboring schools. The aim is also to promote indigenous games among the youth who are in some ways unaware of the vast career possibilities to be explored in our national games and sports.

#### **Digital Practices**

The College has already adopted digital practices in all office and students related work. IQAC collaborates with various departments to organize virtual lectures and talks and interviews of imminent personalities across the world. The College also encourages the faculty to record lectures through screen cast-o-matic v2.0 software for future reference and benefit of the students.

The Administration took the digitalization one step further by transfiguring the students' I-cards into Single Sign-on (SSO) card. This card bearing bar-code is an in-house product developed by the technical team of the college. This one stop card is revolutionary as it makes the entire data just one click away and so is less time-consuming with minimum chances of being faulty and ensures better access to the on-campus facilities like:

- a) Issuing books in library- the students can issue books with the help of SSO card and they would not require any separate library card.
- b) Security- It makes screening easier on special days like student elections, College fest, annual function etc. to avoid any scuffles and untoward incidents in the campus.
- c) Payment of bills- the College is also thinking of creating a pay wallet which will be connected with students' account so as to make their campus experience better.

The Administration is virtually in touch with the non-teaching staff all the time during office hours. All the officials of the College are connected with the Principal through Google worksheet where routine jobs are assigned to concerned officials and are routinely monitored.

The College teaching staff is always updated with real-time LED display in the staffroom which is used for the display of time-table and other important notices.

#### **Inclusive Education and Development**

The practice of Inclusive Education and Development continues from the last year as it serves meaningful benefit for the students. Since the location of the College is very strategic, the students from NCR/East Delhi get the maximum benefit of studying in a premier Delhi University college. The College gives value-based education to the students (as is the vision of the College) and also takes care of the professionalism of the Industry/market and prepares the students for the competitive world outside. Remedial classes, workshops organized by different departments, Placement Cell and Skill Development Cell, industry interaction through CII give the students enough exposure and feel of the professional world.

#### **INFRASTRUCTURE**

The College makes continuous endeavour that its infrastructure remains capable of meeting all the diverse needs of a healthy educational system in a dynamic environment. As recently as the academic year 2015-16, the College has added an entire new building – the Porta Block – to its existing infrastructure. This building has state of the art infrastructure including CCTV surveillance system, and a 100 seater dedicated Conference Hall, Board Room and Teachers Facilitation Centre with up-to-date ICT facilities. A modern and comfortable environment that enables our students to excel in all areas - academics, sports and extra-curricular activities - is what SLC continually endeavours to provide. In this direction, the Staff Room, the Library, the Office and the Canteen have been recently renovated into fine air-conditioned spaces. Proudly, the entire SLC is now a Wi-Fi zone with internet access available to each and every student of the College. As a premier institution, SLC does not remain content with providing state-of-art infrastructure, it also ensures that this infrastructure remains completely accessible to all its students and faculty, including to differently-abled. The new infrastructure additions in the campus are listed below.

- National flag has been permanently installed in the College grounds.
- Green grass carpeting work has been done in the College grounds.
- CCTV under MPLADS fund has been fixated in the whole campuses with coverage of the outside road area.
- Science Labs have been renovated for better conduct of practical classes and examination.
- Two store Rooms have been constructed on the roof of the Library.
- ▶ IQAC room and CCTV control room have been developed.
- A Pathway with Green Corridor has been constructed in front of staff room adjacent to playground joining both the buildings.
- LED flood light has been fixed on the top of the building that gives good visibility of the college name.
- One Organic waste composite machine has been purchased as per NGT direction.
- Chemistry Lab has been developed for BSC (H) students.
- CNG Gas Pipeline has become functional in the campus.
- The College now has a state-of-the-art Reading Room with a seating capacity of 75.
- Overhead water tank with the capacity of 50,000 litres is fully functional in catering to the water demands of the College.

- The College has also introduced an important designated facility for the PwD students of the College in the form of PwD Facilitation Centre which has dedicated computer systems with all the relevant software installed so as to facilitate the smooth imparting of education to PwD students.
- The College has also constructed a state-of-the-art Teacher Facilitation Centre and Board Room to promote research aptitude among the teachers. Board/Committee Room has a seating capacity of 56.
- > The Conference Hall has been refurnished with state of the art facilities.
- The College has also constructed an Amphitheatre for the benefit of the students.
- Over the last year, the College has also developed four Gardens including a herbal garden, two nurseries that have completely changed the outlook of the College building.
- SLC now has an AC furnished cafeteria.
- Bank with ATM.
- Solution Office layout has also been changed to improve the functioning of the administration.
- The College has successfully installed CCTV Camera network in the entire campus.
- The parking area in the College has been fully renovated including its flooring.
- The old building has been fully renovated with 6 washrooms and 2 lifts.
- The college infrastructure has been modernized with the installation of lifts and other proper signage that are PwD friendly.
- A newly furnished reception and waiting area has been constructed.
- During Academic session 2020-21, the College has undertaken major Infrastructural up-gradation with ongoing construction of 2nd Floor in the Old building with several new classrooms, multipurpose Hall, Computer Labs.
- College is also constructing an STP plant.
- Green grass carpeting work was done in College grounds.
- The committee room has been developed in the Porta Block.
- Repair renovation has been done in the College Office for smooth conduct of administrative tasks.

#### **EXTRACURRICULARACTIVITIES**

Life at SLC is not about classroom and academics alone, it goes far beyond that. The College believes that participation in an array of cultural and other activities creates a well-rounded personality; confident and socially aware individuals. Students are encouraged to participate in other activities of their interest, and every possible support is made available to them. Participation in extra- curricular activities not only brings diversity and colour to the lives of students, it enables them to shine in their respective fields, get recognition, as well as win prizes and awards from within and outside the College. The support provided by SLC to students to enable them to excel in the activities of their interest broadly covers two areas. Firstly, all faculty members are required, apart from taking their classes, to guide students in at least one activity that they are comfortable in. Secondly, the College regularly invites scholars, experts and distinguished personalities from various walks of life to enlighten the students and faculty alike on the latest ideas, trends, as well as inputs and guidance for achieving excellence in those fields. This is done under the aegis of different Academic and Cultural Associations/ Societies that exist in the College.

#### **Students' Union**

SLC students have an active say in all affairs concerning the welfare of the students, and this say is exercised through the Students' Union, which is a body of all the students admitted to the College. This body not only leads to a healthy development of participatory and democratic practices among the students, it also enables them to articulate their needs and demands. Each year students get an opportunity to contest elections and get elected to this body. The Students' Union functions under the overall guidance and supervision of the Students' Union Advisory Committee, and it also organizes the Annual Cultural Festival, consisting of activities like dance, music and fashion show.

#### NCC

Students of SLC are expected to be sensitive and socially aware citizens. The College offers plenty of opportunities to students to put these values to practice through NCC and NSS. The NCC unit of SLC (M) operates under the banner of NCC unit of Shyam Lal College (evening). NCC imbibes in its cadets values of discipline, hard work, and trains them to protect fellow citizens during times of adversity such as security threats to a community or to the nation itself. NCC girls of SLC participated and organized Self-defense Camp, Yoga Camp, Tree Plantation drive and save Yamuna Campaign. Delhi Police supported the NCC unit of the



College in latter's Nirbhek Movement. Students enrolled with the NCC unit are instructed in rifle shooting, the use of ammunitions, basic first-aid, mountaineering and trekking through rigorous physical exercise and participation in drills and parades.

#### NSS

With the moto of "Not Me But You", the NSS unit of SLC is actively involving youth in various community service activities. Committed towards the welfare of society, the NSS unit of SLC regularly undertakes community outreach events like Blood Donation Camps and social awareness campaigns in the College to expand social awareness among the students and help them participate in social welfare activities. In continuation with its social responsibility, this academic session also, the NSS organized a "Rally on Water Conservation & Cleanliness"; "Rally for Dengue & Malaria Awareness"; "Donation Drive". The college

Under the program, students participated in fitness exercise like daily morning steps, jogging and running at their home place.

#### **Sports**

Sports and fitness activities are an integral component of SLC. The college has full-fledged Department of Physical Education which provides unmatched and state-of-the-art facilities for sports like Hockey, Kabbadi, Baseball, Cricket, Football, Kho-Kho, Chess, Carrom, Yoga, Judo and Athletics. Special emphasis is laid on

improving not only the health component and lifestyle but also to instill the qualities of team cohesion and sportsman-spirit. Sports, as a hobby, provides an option to students for healthy and stress free living, and as a profession, provides an attractive career option to the students who have the discipline to work hard and excel in this area. The College sports boasts of not only producing players of University, State and National levels but also of the existence of rich expertise, capable infrastructure and efficient support staff available inhouse, apart from hiring coaches and experts for various sports from outside. SLC takes pride in the fact that the



College has one of the biggest, lush green and well-maintained sports grounds in the University. All students enrolled in the College can use the ground for various sports activities, events, practices etc. The College students, particularly those enrolled under the Sports quota, have over the years, displayed exemplary performance in their respective sports. SLC's Inter-varsity Invitational Hockey Tournament in the fond memory of its Founder Chairman Padmashree Late Shri Lala Shyam Lal Gupta has become an integral part of the University's sports calendar wherein teams of both women and men from various Colleges / Institutions of Delhi University are invited to participate in the tournament. The college has an open gym facility in the college and has also appointed a dedicated Yoga instructor for conducting regular yoga camp, for faculty and students.

#### **ACADEMIC SOCIETIES**

# Admissions to Undergraduate Courses 2021-2022

Admissions to undergraduate (UG) courses in the Shyam Lal College are merit-based (that is, based on marks scored in Class XII Board/qualifying examinations).

- 1. All Candidates must register through the University of Delhi online admissions portal www.admission.uod.ac.in
- 2. All undergraduate admissions for 2021-22 will be administered only through Delhi University portal.
- 3. There is no offline admission for any Candidate.
- 4. Only eligible Candidates who have registered online through the University portal can be considered for admission.
- 5. Candidates will be required to appear in person for verification of their original documents, as and when notified by the University/College.
- 6. All admission procedures are to be completed by the Candidate using the unique login ID they create on the Delhi University Undergraduate admission portal.

## Eligibility Criteria for Undergraduate Courses

- The Candidate must be a citizen of India. (Candidates seeking admission under the Foreign Students' category to apply separately on Foreign Students' Registry website, http://fsr.du.ac.in.)
- The Candidate should have passed the Class XII examination of any Board/University examination in India or in any foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU).
- The Candidate should have "passed" individually in each subject required (including practicals if any) for calculating merit and eligibility to the program they seek admission in.
- Candidates with gap year(s) will not be at any disadvantage for the purpose of admission to undergraduate programs.
- Candidates under the UR/SC/ST/OBC/EWS categories are eligible to seek admission based on both merit and entrance tests to programs in all Colleges/ Departments (except Minority Colleges, wherein some categories may not be applicable).
- Candidates from the Sikh and Christian minorities may also seek admission under the minority quota in the Minority Colleges of the University.
  - The following categories are designated "supernumerary":
    - i) PwBD (Persons with Benchmark Disabilities);
    - ii) CW (Children/Widows of Personnel of the Armed Forces including Para-Military);
    - iii) KM (Kashmiri Migrants);
    - iv) Prime Minister's special scholarship for Jammu and Kashmir;
    - v) SS (Nominated Sikkimese Students);
    - vi) WQ (Ward Quota);
    - vii) ECA(Extra-Curricular Activities);
    - viii) Sports.

# Note:- The Process of online registration and fees payment to be done through University undergraduate admissions portal.

Shyam Lal College offers merit based admission to undergraduate courses in various streams namely Arts, Sciences and Commerce. College has implemented the Choice Based Credit System (CBCS) for all its undergraduate

Admission to these courses is made through the various criteria and procedures specified by the University.

### Program-wise Merit List for Merit-based UG Admissions

The Suggested Program and Category-wise Merit List published on the University website shall be adhered to by all the Colleges of University of Delhi.

The marks entered by the Candidate (at the time of registration on the UG Admissions Portal) will serve as the basis for computing the total marks for program-specific combinations of "Best Four" for admission in programs through the faculties of Arts, Commerce, Mathematical Sciences, Music, Social Sciences, Applied Social Sciences & Humanities, and "Three Subjects" for admission in programs under faculties of Sciences and Applied Sciences. This may be displayed on the UG Admissions Portal before the declaration of First Cut-Off marks by the Colleges/Departments.

A separate updated merit list will be published as an Annexure for Candidates whose marks are updated after the publication of the Suggested Program and Category-wise Merit List.

In order to facilitate the said Merit List, the Candidate may choose subjects as relevant from List A and List B. **Relaxations in Program-specific Eligibility Criteria** 

- To determine their eligibility and merit, Candidates from the SC/ST categories shall be given a relaxation to the extent of 5% in the respective eligibility criteria and merit for admission prescribed for Candidates from the UR category. If, after giving 5% relaxation, these reserved seats still remain vacant, further relaxation would be given to the extent required in order to fill all the reserved seats in the program concerned. Eligibility in such cases is pass percentage.
- To determine the eligibility and merit, Candidates from the OBC category shall be given a relaxation in the respective eligibility in the qualifying examination to the extent of 10% of the eligibility marks prescribed for Candidates from the UR Category. For example, if the minimum eligibility for admission to a program is 40% for the UR Category Candidates, the minimum eligibility for the OBC category will be 36% (i.e. 40% minus 10% of 40%).
- Candidates from the PwBD category shall be given a relaxation in the respective eligibility for the program concerned in the qualifying examination to the extent of 5%. For example, if the minimum eligibility for admission to a program is 40% for the UR Category Candidates, the mini- mum eligibility for the PwBD category will be 38% (i.e. 40% minus 5% of 40%).
- Candidates from the CW category shall be given a relaxation of 5% in the respective eligibility for the program concerned in the qualifying examination. For example, if the minimum eligibility for admission to a program is 40% for the UR Category Candidates, the minimum eligibility for the CW category will be 38% (i.e. 40% minus 5% of 40%).
- Eligibility Criteria for merit-based admissions under the EWS category shall be identical to that of UR category.

### **Computing Merit Score: General Guidelines**

Program specific eligibility criteria determines the merit score on which admission to each program is based. Candidates must study these criteria carefully to understand if they qualify. The detailed program specific criteria are in sections 2.2-2.9 below.

- 1. All academic subjects may be treated as "elective." The subjects eligible for computation (subject to program-specific criteria) are listed above in List A and List B.
- 2. The University may define any other relevant subjects as academic/elective for a particular program.
- 3. Merit is calculated through program-specific combinations of marks obtained in the qualifying examination in the "Best Four" subjects for admission to programs through the faculties of Arts, Commerce, Mathematical Sciences, Music, Social Sciences, Applied Social Sciences & Humanities, and program-specific combinations of "Three Subjects" for admission to programs under the faculties of Sciences and Applied Sciences

### Special Instructions for Boards other than CBSE

- 1. If a paper's title does not match with what is specified in List A and List B above, it is mandatory for the Candidate to provide a content equivalence certificate from the Principal/Head of the Institution last attended, certifying that the paper's content is equivalent to NCERT Class XII syllabus for that paper. This equivalence certificate must be accompanied by a copy of the syllabus of the paper attested by the Principal/Head of the Institution. However, the University of Delhi's decision on the matter will be final and binding.
- 2. If the Candidate has studied "Botany" and "Zoology" separately, the total of marks in both these papers must be entered in the respective fields for theory and practicals under the heading "Biology" in the field provided in your admission form.
- 3. If the Candidate's marksheet contains both Class XI and XII marks, the Candidate must enter only the Class XII marks in the respective fields provided in the admission forms.
- 4. Candidates should have passed theory and practical separately. Any paper with both theory and practical component will be considered only in the ratio 70 (theory) : 30 (practical) if the theory component of the paper is less than 70%. The Candidate should separately fill into the online Admission Form the marks obtained and maximum marks for theory and practical each, and the totals, as per their marksheet. In case the theory/practical breakup is not specified, the Candidate will be required to enter only their total marks in the first field ("Theory") for that paper in the online Registration Form. (See Appendix IX, Example 1 for sample calculations.)
- 5. "Internal Assessment" marks, if any, mentioned in the marksheet will not be used for any calculations. (See Appendix IX, Example 2 for sample calculations.)
- 6. Any discrepancy in the entry of marks pertaining to theory, practicals or totals will be the sole responsibility of the Candidate. Candidates are advised to exercise utmost care in filling up the registration form as errors in entry may lead to summarily rejection of the form.

### Merit-based admission to B. A. (Hons.) courses offered through the Faculty of Arts

A maximum of two language subjects may be allowed for the calculation of marks for best four combination; however, out of the two languages, only one could be a core language.

## **Undergraduate Merit-based Admission Process**

## Step I: Registration on the UG portal

The Candidate uses the university UG Admissions portal to create their personal username and password, fills in their registration form, chooses their programs of interest, and uploads the required documents. (Detailed guidelines on how to register will be uploaded on the University website in due course). The Candidates must exercise extreme care in filling up their form. Much of the information entered by theCandidates into the form will not be allowed to edit and correct after submission of the form.

- 1. All the candidates seeking admission to the Undergraduate (UG) programs are required to register online.
- 2. Any first time user, in order to access UG Admission Portal, need to register on the portal with a valid email ID (email ID once registered on Portal can't be used for any other registration for admission in DU.
- 3. Candidates who do not have a valid e-mail ID must create an e-mail ID before proceeding.
- 4. The Candidate needs to keep this e-mail ID handy because it will be required toaccess his / her account on the portal as well as for all the future correspondence throughout the admission process and subsequent to admission process also

- 5. The default settings allow all Candidates to register for all programs (without any penalties).
- 6. The Candidates will be eligible to take admission in all the colleges and programs provided they satisfy the cut-off of the colleges and the eligibility for the selected programs.
- 7. If Candidates have examination results pending or have reappeared in papers, they will be able to update these marks by logging into their Dashboards till the last 3 days before the date of admissions in the University (as and when notified byDU)
- 8. Utmost care must be exercised in uploading the documents. Candidates will need scanned copies of the certificates on the basis of which they wish to claim admission
  - (a) Class X certificate
  - (b) Class XII certificate
  - (c) Relevant reservation certificate issued by competent issuing authority
  - (d) Self attested copies of requisite certificates for admission under sports/ECA Quota.
  - (e) Link of the uploaded clip for admission against music
  - (f) Photo identity card (Aadhar Card, Driving License, PAN Card, Voter Identity Card, Passport or School Identity Card)
- 9. Candidates will be responsible for all the information they upload, including copies of certificates. They will also be responsible for the quality and authenticity of the files they upload. The Candidates will be able to see the preview of their form and the uploaded documents. The Candidates are advised to take all care to avoid rejection on this basis during the admission process.

## Step II: Payment of the registration fees

The registration form will be deemed submitted only after realization of the relevant registration fee. This fee must be paid only through the link provided through the Candidate's Dashboard. There is no method available to Candidates other than this online link generated for payment of the registration fee. When the Candidate has successfully submitted the registration fee online, they are advised to keep records of the payment's transaction ID, Credit Card/ Debit card/ Netbanking details and date of transaction as proof for future reference. Further, the Candidates are advised to complete the process well before the deadline in order to avoid any last minute glitches.

For guidelines related to cut offs and other admission related announcements, keep checking the DU website (www.admission.uod.ac.in) on regular basis.

### **Reservations for SC/ST/OBC/EWS**

The merit list for the unreserved category (UR) seats will comprise all the Candidates in order of merit. No one will be excluded from the same. In other words, the merit list for unreserved (UR) category will also include SC / ST / OBC / EWS Candidates, irrespective of category, if they meet the criterion of merit for UR category.

No Candidate can be excluded from the UR category merit list just because the Candidate belongs to or has applied under SC/ST/OBC/EWS category. Such a Candidate is entitled to be considered under the UR category, as well as under the reserved category. Admission to UR category seats will be strictly in order of merit without excluding SC/ST/OBC/EWS Candidates.

**Discrimination on the basis of category/ caste is completely unlawful.** The University of Delhi does not tolerate discrimination against any Candidate/student on this basis. Strict action will be taken against any violations.

Candidates seeking admission under SC/ST/OBC/EWS category will have to produce for verification certificates in their own names

### Reservation of Seats for Scheduled Caste (SC) and Scheduled Tribe(ST) Candidates

- 22.5% of the total numbers of seats is reserved for Candidates belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7.5% for Scheduled Tribes, interchangeable if necessary).
- It is a statutory obligation on the part of Colleges to fill all seats reserved for Scheduled Caste / Scheduled Tribe Candidates.

- Colleges shall not refuse admission to any SC/ST Candidate on the basis of medium of instruction. Any deficiency in the knowledge of any particular language should be addressed; for this purpose remedial classes may be arranged by the College by utilizing grants available from University Grants Commission.
- Relaxation to the extent of 5% in the minimum marks shall be given to the Candidates be-longing to SC and ST category to determine their eligibility and merit for admission to the program concerned.
- In case, after giving 5% relaxation, the reserved seats still remain vacant, further relaxation would be given to the extent required in order to fill all the reserved seats. (AC Resolution A88, 14.6.1983) (EC Resolution 157, 24.12.2001). It is obligatory for all Colleges/Departments to fill all the seats reserved for SC/ST Candidates. Minimum Eligibility in these cases is pass percentage.

The following are empowered to issue the requisite SC/ST certificate:

- a) District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/ Addl. Deputy Commissioner/ Deputy Collector/ 1st class Stipendiary Magistrate/ City Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Com- missioner.
- b) Chief Presidency Magistrate/Addl. Chief Presidency Magistrate/ Presidency Magistrate.
- c) Revenue Officer not below the rank of Tehsildar.
- d) Sub-Divisional Officer of the area where the Candidate and/ or his family normally resides.
- e) Administrator/ Secretary to the Administrator/ Development Officer (Lakshadweep Islands).

The Candidate must note that the SC/ST Certificate from any other person/authority shall not be accepted in any case. If the Candidate happens to belong to SC or ST, Candidate's caste/ tribe must be listed in the appropriate Govt. of India Schedule.

The Caste Certificate should clearly state: (a) Name of his/ her caste/ tribe (b) whether candidate belongs to SC or ST (c) District and the State or Union Territory of Candidate's usual place of residence, and (d) the appropriate Govt. of India Schedule under which his/ her caste/ tribe is approved as SC or ST.

If the Candidate does not have their SC or ST caste/tribe certificate at the time of registration/applying, they may upload the acknowledgement slip of the SC or ST caste/tribe certificate application. However, at the time of admission, the Candidate will have to produce the valid original SC or ST caste/tribe certificate.

However, if an SC/ST Candidate seeks admission under some other category (for example: PwBD/Employee Ward, etc.) the Candidate should satisfy the minimum eligibility requirement for that particular category.

# Note: SC/ST Candidates who get admission under open merit (unreserved) shall not beincluded in the reserved quota, i.e. 22.5% (15% for SC and 7.5% for ST).

### Reservation of Seats for Other Backward Classes (OBC, Non-CreamyLayer, Central List)

- 27% seats will be reserved for the Candidates belonging to Other Backward Classes (OBC) (non-creamy layer, central list).
- At the time of giving admission to an OBC Candidate, the College will ensure that the caste is included in the Central List of OBC (the OBC status is to be determined on the basis of the Central (Govt. of India) List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes (available at the website http://ncbc.nic.in/ backward classes/index.html.)
- The certificate must mention non-creamy layer status of the Candidate (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93- Estt. (SCT) dated 15.11.1993).
- The OBC Candidates who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs only, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'non-creamy layer' status of the Candidates as per DOPT Office

Memorandum No. 36036/2/2013-Estt. (Res- I) dated 31 March 2016). The validity of the non-creamy layercertificate shall be for the financial year 2021-2022 (for Assessment year ending on March 31, 2021), issued on or after 31st March, 2021.

- If the Candidate does not have the OBC non-creamy layer certificate of the latest financial year 2021-2022 at the time of registration, the Candidate may upload the previously issued (older) OBC noncreamy layer certificate or the acknowledgement slip of OBC non-creamy layer certificate application. However, at the time of admission, the Candidate must produce the recent financial year's (2021-22) OBC non-creamy layer certificate, issued by the same competent authority. This additional certificate must have reference of the Candidate's already issued original caste certificate.
- The OBC Candidates shall be given a relaxation of 10% in the minimum eligibility marks of the said program and for the admission entrance test a relaxation of 10% of the mini- mum eligibility marks prescribed for General/UR Category Candidates. For example, if the minimum eligibility for admission to a program is 40% for the UR Category Candidates, the minimum eligibility for the OBC category will be 36% (i.e. 40% minus 10% of 40%).
- It is a statutory obligation on the part of Colleges to fill all the seats reserved for OBC Candidates.

### **Reservation policy for Economically Weaker Sections (EWS)**

As per the University of Delhi notifications (Reference No. Aca. I/Reservation of EWSs/2019/63 Dated 28th March 2019 and Reference No. Aca. I/Reservation of EWSs/2019/101 Dated 15th May 2019), for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments / Centres / Colleges have reserved 10% seats for admission for the same in the Academic Year 2021-22. The eligibility of such Candidates willbe decided on the basis of fulfilling criteria prescribed in the above notifications, and subject to submission of documents, issued by the competent authority, in the format provided in Appendix V.

#### Disclaimer

- 1. No further extension/relaxation for submitting the required certificate will be given under any circumstances.
- 2. If the applicant by oversight or mistake or otherwise for any other reason is admitted without recent finance year's (2021-22) OBC non-creamy layer certificate, the university/department reserves the right to cancel the admission without prior notice and without any liability.

Reservation for Persons with Benchmark Disability; for Children/Widows of Personnel of the Armed Forces; Kashmiri Migrants; PM's Special Scholarship for J&K; nominated Sikkimese Students; Ward Quota

#### Reservation of Seats for Persons with Benchmark Disabilities (PwBD)

As per the provisions of Rights of Persons with Disabilities Act, 2016, not less than five percent (5%) seats are reserved for Persons with Benchmark Disabilities. "Person with benchmark disability" means a person with not less than forty percent (40%) of a specified disability where specified disability has not been defined in measurable terms and includes a person with dis- ability where specified disability has been defined in measurable terms, as certified by the certifying authority. It may be noted that the erstwhile Persons with Disability Act, 1995, under which reservation for Persons with Disabilities in admissions was provided earlier has now been repealed.

PwBD Candidates shall be given a relaxation in the program-specific eligibility in the qualifying examination and in the admission entrance test to the extent of 5%, till seats are filled. For example, if the minimum eligibility for admission to a program is 40% for the UR Category applicants, the minimum eligibility for the PwBD category will be 38% (i.e. 40% minus 5% of 38%).

The following specified categories of disabilities as mentioned in the Schedule to the Rights of Persons with Disabilities Act, 2016 [See clause (zc) of section 2 of Act of Rights of Persons with Disabilities Act, 2016] are eligible to get the benefit of the said reservation.

### I. Physical disability

- A. Locomotor disability
- 1. Locomotor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or

both), including-

- 2. "leprosy cured person" means a person who has been cured of leprosy but is suffering from—
- (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifestation of deformity;
- (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
- (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
- 3. "cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or morespecific areas of the brain, usually occurring before, during or shortly after birth;
- 4. "dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;
- 5. "muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterised by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;
- 6. "acid attack victims" means a person disfigured due to violent assaults bythrowing of acid or similar corrosive substance.

## B. Visual impairment

- 7. "blindness" means a condition where a person has any of the following conditions, after best correction -
- (i) total absence of sight; or
- (ii) visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eyewith best possible correction; or
- (iii) limitation of the field of vision subtending an angle of less than 10 degree.
- 8. "low-vision" means a condition where a person has any of the following conditions, namely:
- (i) visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
- (ii) limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.

## C. Hearing impairment

- 9. "deaf" means persons having 70 DB hearing loss in speech frequencies in both ears;
- 10. "hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
- 11. "speech and language disability" means a permanent disability arising out of condi-tions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.
- **II. Intellectual disability,** a condition characterised by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including—
  - 12. "specific learning disabilities" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to

comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;

13. "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

## III. Mental behaviour

14. "Mental illness" means a substantial disorder of thinking, mood, perception, orienta- tion or memory that grossly impairs judgment, behaviour, capacity to recognise reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterised by subnormality of intelligence.

### IV. Disability caused due to

- (a) Chronic neurological conditions, such as—
  - 15. "multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are dam- aged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
  - 16. "Parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle- aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.

### (b) Blood disorder—

- 17. "hemophilia" means an inheri1table disease, usually affecting only male but trans- mitted by women to their male children, characterised by loss or impairment of the normal clotting ability of blood so that a minor wound may result in fatal bleeding;
- 18. "Thalassemia" means a group of inherited disorders characterised by reduced or ab- sent amounts of haemoglobin.
- 19. "Sickle cell disease" means a haemolytic disorder characterised by chronic anemia, painful events, and various complications due to associated tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of haemoglobin.

### IV. Multiple Disabilities (more than one of the above specified disabilities)

- 20. Multiple disabilities including deaf blindness which means a condition in which a per- son may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.
- 21. Any other category as may be notified by the Central Government

# Candidates must furnish a valid disability certificate issued by a recognized Government hospital, bearing a photograph of the candidate.

### Concessional/Waiver of fees in respect of Persons with Disabilities (PwBD)

- a) Candidates with physical disabilities pursuing various programs of study in the Faculties, Departments, Centres, and Institutions / Colleges of the University shall be exempted from payment of fees, including examination fee and other University fees, except Admission fee, subscription towards Delhi University students' Union and Identity Card fee(As per amendment to Ordinance X(4) of the University).
- b) PwBD Candidates who meet the cut-off for the unreserved category and will take admission in the unreserved category (UR) will pay the fee relevant for PwBD Candidate.
- c) As per the Executive Council Resolution No. 50 dated 03.11.2012, students with physical disabilities residing in different Hostels / Halls of the University are exempted from payment of all hostel fees and

charges except refundable caution fee and the mess fees. Persons with Physical Disabilities who are students shall pay 50% of the Mess fee and the remaining 50% of their Mess Fee will be met by the University of Delhi. Similar norms are to be adopted by the Colleges in respect of PwBD Students residing in various hostels of the Colleges.

d) PwBD students who are getting fellowships / financial assistance shall be exempted from payment of fees / charges / mess fees subject to the following conditions. All admitted SC/ST, OBC, EWS, PwBD students in colleges who are eligible for fellowships should submit their scholarship forms to the requisite office by February for timely processing.

Disability Certificates issued after 01.06.2021 must be as per the Gazette Notification no. 1736 (E) dated 05.05.2021 issued by the Department of Empowerment of Persons with Disabilities and applied through UDID portal. However, Disability Certificates issued before 01.06.2021, will be considered as per other existing applicable rules and notifications of Department of Empowerment of Persons with Disabilities and University of Delhi.

### Reservation for Children/Widows of Personnel of the Armed Forces (CW)

- 1. Five percent (5%) of seats are reserved for Candidates under this category, program-wise in all colleges.
- 2. All such Candidates have to upload the Educational Concession certificate (as per the format provided in Appendix VI) to be issued by any of the following authorities on the proper letterhead:
  - (a) Secretary, Kendriya Sainik Board, Delhi.
  - (b) Secretary, Rajya Zila Sainik Board.
  - (c) Officer-in-Charge, Record Office.
  - (d) 1st Class Stipendiary Magistrate.
  - (e) Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

No other format shall be permissible. Proofs of the CW category in the form of ID card of parent or dependent, Medical card, Ration card, CSD card, etc. are not admissible in lieu of certificate in correct format. The priority must be clearly mentioned in the certificate. Certificates that do not mention the relevant priority will not be considered.

Admission may be offered to the Children/Widows of Personnel of the Armed Forces (Priority to IX) including Para-Military Personnel (only Priority I to V), in the following order of prefer- ence:

- Priority I Widows/Wards of Defence personnel killed in action;
- Priority II Wards of Defence Personnel disabled in action and boarded out from service with disability attributable to military service;
- Priority III Widows/Wards of Defence Personnel who died while in service with death at- tributable to military service;
- Priority IV Wards of Defence Personnel disabled in service and boarded out with disability attributable to military service;
- Priority V Wards of Ex-servicemen and Serving personnel, including personnel of police forces who are in receipt of Gallantry Awards;
  - i. ParamVir Chakra
  - ii. Ashok Chakra
  - iii. MahaVir Chakra
  - iv. Kirti Chakra

- v. Vir Chakra
- vi. Shaurya Chakra
- vii. President's Police Medal for Gallantry/President Gallantry Medal for the fire services personnel
- viii. Sena Medal (Gallantry), Nau Sena Medal (Gallantry), Vayu Sena Medal (Gallantry)
- ix. Mention-in-Despatches
- x. Police Medal for Gallantry/Gallantry Medal for fire services Priority VIWards of Ex-Servicemen.

## Reservation of Kashmiri Migrants (KM) (Supernumerary Seats)

- 1. All the wards (sons/daughters) of Kashmiri Migrants who wish to be considered for admission to various undergraduate programs of the University have to register online as per the schedule notified by the University.
- 2. Up to 5% seats are reserved program-wise in all colleges for the wards of Kashmiri Migrants.
- 3. All the wards of Kashmiri Migrants will have to upload a certificate of registration as Kashmiri Migrants issued by Divisional Commissioner/ Relief Commissioner. Admission of Wards of Kashmiri Migrants will be based on cut-offs to be announced by the Colleges. A concession of maximum 10% in the last cut-off marks fixed for unreserved category. Candidates shall be extended to the Kashmiri Migrants. Reservation under this category is not available in programs where admission is based onentrance tests.

## Prime Minister's Special Scholarship Scheme for J&K students

The Candidates selected under Prime Minister's special scholarship scheme for J&K students will be admitted directly to the Colleges. Reservation under this category is not available in programs where admission is based on entrance tests. Candidates must register on the University Portal as per schedule to be announced on University website.

## Nomination of Seats for Sikkimese Students

Sikkimese students nominated by the Govt. of Sikkim shall be considered for admission by the University in Colleges where hostel facilities are available (AC Resolutions 51 dated 05/06/1980 and 122 dated 17/12/1990). The allocation of Sikkimese students for admission as well as for hostel accommodation in respective colleges be made by the Vice-Chancellorat his discretion. Reservation under this category is not available in programs where admission is based on entrance tests. Candidates must register on the University Portal as per schedule to be announced on University website.

## Seats for Ward Quota

Admission to the wards of University and its College employees, both teaching and non-teaching will be done as per Academic Council resolution 9 a & b dated 27.11.2020.

Due to the unprecedented situation of COVID-19 pandemic and prevailing public health guide-lines, admission based on ECA will take place for the category of NCC and NSS only and admission based on Sports will take place without the conduct of Sports Trail.

- 1. Colleges must provide sports facilities and encourage all students to participate in Sports and Extra-Curricular Activities (ECA) by introducing inter-class competitions and mass sports. Representation of at least 1% each (of total intake capacity of the college) of ECA and Sports is mandatory for all colleges, subject to a ceiling of 5% (of total intake capacity of the college) in total for ECA and Sports together.
- 2. The actual number of seats to be filled based on ECA and Sports is decided given the facilities available, the requirement of the colleges and other relevant factors.
- 3. Admission based on ECA and Sports is not available in programs where admission is based on the entrance test.
- 4. The allotment of program and college to the Candidate on the basis of ECA and Sports will be done in a centralized manner by the University. There will be no restriction of program (subject wise).
- 5. Additional information regarding the schedule of ECA and Sports and availability of seats will be notified on the DU website.
- 6. A Candidate submitting false/fake certificates for seeking admission on the basis of ECA and Sports shall be debarred from admission to any College for three years. Such admissions will be cancelled and FIR will also be registered.

## Extra-Curricular Activities (ECA) and Sports Quota

Due to the unprecedented situation of COVID-19 pandemic and prevailing public health guidelines, UG merit based admission under ECA Quota will take place without the conduct of online/offline Trials.

### ECAQUOTA

- 1. Colleges must encourage all students to participate in Extra-Curricular Activities (ECA) by introducing inter-class competitions and providing necessary infrastructure. Representation of at least 1% each (of total intake capacity of the college) to ECA and Sports is mandatory for all colleges, subject to a ceiling of 5% (of total intake capacity of the college) in total for ECA and Sports together.
- 2. The total number of seats to be allocated to ECA is decided based on the facilities available, the requirement of the colleges and other relevant factors.
- 3. Admission to UG Programs under ECA Quota is available only for merit based programs and is not available in programs where admission is based on entrance test.
- 4. The candidate seeking admission under ECA Quota is required to register online on the University of Delhi UG Admission portal.
- 5. The allotment of program and College to the candidate on the basis of ECA will be done in a centralized manner by the University through a centralized ECA Merit List and based on the preferences of Colleges and programs indicated by the applicant. The allotment will be based on the rank of the applicant in the order of centralized ECA Merit List, program-specific eligibility criteria, the availability of program and ECA Quota/sub-Quota in the College.
- 6. Additional information regarding the schedule of ECA admissions and ECA Seat Matrix for Undergraduate Admissions 2021-2022 will be notified on the University of Delhi Admission website. The candidates are requested to keep checking the DU website regularly for further guidelines and other admission related information for admission under ECA Quota..
- 7. A candidate submitting false/fake certificates for seeking admission on the basis of ECA shall be debarred from admission to any College for three years. In such cases admissions will be cancelled and strict legal action will also be taken.

## Guideline for Admission under Extra Curricular Activities (ECA)

- The University of Delhi has decided to include all the fourteen categories of last year of Extra Curricular Activities (ECA) under the admission through ECA Quota in the UG Programs.

# Important Note: Admission to these Categories and sub-categories is subject to seats offered by the Colleges.

- The University will not entertain applications from candidates for admission under those ECA Categories/subcategories for which seats are NOT offered by any College.
- Candidates may register for a maximum of three ECA categories.
- There will be additional registration fee of Rs. 100 to apply under ECA Quota in addition to charges for (UR/OBC/SC/ST/PwBD/EWS) registration.
- Admissions under ECA will be done based on the Merit/ Participation certificates of the Candidates. Due to extraordinary situation arising out of the Covid-19 pandemic, this year the Candidates are allowed to upload certificates of the preceding four years.(Only for academic year 2021-2022). Candidates would be required to upload a maximum of Best Five certificates of preceding four years (1st May 2017 30th April 2021).

- The forensic examination of certificates of all admitted candidates under the ECA Quota will be done.

#### • National Service Scheme (NSS)

- 1. Due to extraordinary situation arising out of the Covid-19 pandemic, this year the Candidates are allowed to upload certificates of the preceding four years.(Only for academic year 2021-2022). Candidates would be required to upload a maximum of Best Five NCC Certificates of preceding four years -1st May 2017 to 30th April 2021.
- 2. Undated certificates and without stamp and signature of the authorized signatory of NSS will not be considered for marking.
- 3. Certificate should mention the Candidate as a NSS Volunteer in the participated activity.
- 4. Work Diary should not be hand written. The Work Diary should have the Programme Officer and Principal's signature and stamp on every page.
- 5. Certificates uploaded by the Candidate shall be scrutinized and evaluated out of a maximum of 100 marks. Candidate must secure minimum 04 Marks in the Marking of the uploaded NCC Certificates to be eligible for Admission on the basis of ECA.

Marks will be awarded to Candidates based on their performance under five different heads given below:

- a) Regular Activity
- b) Working Hours
- c) National Camps
- d) Special Camps
- e) Pre-RD Camp

### In case of Tie

Candidates securing same total marks in ECA Certificates in the same ECA Quota and eligible for admission in the same College and same Program may be resolved in the following order: -

- i) The candidate securing higher marks in the best certificate shall be awarded admission.
- ii) If the candidates have same marks in the best certificate, the second best certificate marks shall be considered to break the tie.
- iii) If the candidates have same marks in the second best certificate, the third best certificate marks shall be considered to break the tie.
- iv) If the candidates have same marks in the third best certificate, the fourth best certificate marks shall be considered to break the tie
- v) If the candidates have same marks in the fourth best certificate, the fifth best certificate marks shall be considered to break the tie.

### In case the tie still persists then the following tie –breaking rule will be adopted:

- i) The Candidate with a higher percentage of marks (aggregate of best four subjects including one language) in the qualifying examination will be considered first for allotment/admission.
- ii) The Candidate with higher percentage of marks (aggregate of best five subjects including one language) in the qualifying examination will be considered first for allotment/admission.
- iii) The Candidate with the earlier date of birth (as mentioned in class X certificate) will be considered for allotment/ admission.

### If the Tie persists, all the Candidates may be admitted.

- The grievance related to the award of marks of uploaded ECA Certificates shall be redressed by the UG ECA Grievance Committee of the University. The decision of the UG ECA Grievance Committee of the University will be final.
- The Candidate must submit an Undertaking at the time of admission stating that the Candidate will participate in the Cultural/NSS/NCC activities for the College and University as determined by College/University failing which the College has the right to cancel the admission if the Candidate violates the Undertaking during their entire period of Undergraduate program of study.

## Admission to Sports Quota

# Due to the unprecedented situation of the COVID -19 pandemic and prevailing public health guidelines, admission on the basis of ECA and Sports will take place without the conduct of Trials.

- 1. Colleges must provide sports facilities and encourage all students to participate in Sports and Extra Curricular Activities (ECA) by introducing inter-class competitions and mass sports. Representation of at least 1% each (of total intake capacity of the college) of ECA and Sports is mandatory for all colleges, subject to a ceiling of 5% (of total intake capacity of the college) in total for ECA and Sports together.
- 2. The actual number of seats to be filled based on ECA and Sports is decided given the facilities available, the requirement of the colleges, and other relevant factors.
- 3. Admission based on ECA and Sports is not available in courses where admission is based on the entrance test.
- 4. The allotment of course and college to the applicant on the basis of ECA and Sports will be done in a centralized manner by the University. There will be no restriction of course (subject-wise) for admission to the eligible applicant.
- 5. Additional information regarding the schedule of ECA and Sports and the availability of seats will be notified on the DU website.
- 6. An applicant submitting false/fake certificates for seeking admission on the basis of ECA and Sports shall be debarred from admission to any College for three years. Such admissions will be canceled and FIR will also be registered.

### Guidelines for Admission on the Basis of Sports

The Colleges shall communicate on the DU UG Admission portal the total number of seats under Sports Quota (Supernumerary) along with requirements in different Games/Sports in Men/Women as applicable.

The admission on the basis of Sports shall be administered through Sports Admission List based on the marks and rank obtained in the Centralized Sports Marks Award List which will be based on the evaluation of marking of uploaded Merit/Participation Sports Certificate/s, order of the preferences of course and college and subject to availability of Game/Sport in the College as indicated by the applicant.

- 1. The applicant seeking admission on the basis of Sports is required to register online on the DU UG Admission portal.
- 2. Applicants can register with one registration number for one Game/Sport. Applicants can register for a maximum of three Games/Sports.
- 3. An additional registration fee of Rs. 100/- for each Game/Sport will apply in the Sports category in addition to charges applicable for (UR/OBC/SC/ST/PWD/EWS) registration.

### Admission herein will be based on:

- I. **Direct admission** on the basis of Category A of the Criteria for Marking of Merit/Participation Sports Certificate.
- **II.** Admission on the basis of Category B, C& D of the Criteria for Marking of Merit/Participation Sports Certificate.
- I. Direct admission on the basis of Category A of the Criteria for Marking of Merit/Participation Sports Certificate

Sports persons who have represented India in the under-mentioned Competition(s), recognized and funded by the Ministry of Youth Affairs and Sports (MYAS) will be given Direct Admission for the Game/Sport at Point no. II (B) where the requirement for the Game/Sport has been given by the Colleges.

- a) Olympic Games by the International Olympic Committee(IOC)
- b) World Championship/World Cup by International Sports Federations(ISF)
- c) Commonwealth Games by Commonwealth Games Federation(CGF)
- d) Asian Games by Olympic Council of Asia(OCA)

- e) Asian Senior Championships by International Sports Federations(ISF)
- f) South Asian Games (SAG) by South Asia Olympic Council(SAOC)
- g) Paralympic Games by International Paralympic Committee(IPC)

**II.** Admission on the basis of Categories B, C & D of the Criteria for Marking of Merit/ Participation Sports Certificate

## A. Maximum 100 Marks for Merit/Participation Sports Certificate

- 1. Criteria for marking of Merit/Participation Sports Certificate display the marks for different levels of Game/Sport competitions.
- 2. Sports Certificate of Invitational / Memorial / Open / Prize Money League / Selection Trial /Squad/ Ranking competitions will not be considered. Letter/ Letterhead of Merit/Participation in Sports competitions will also be not considered.
- 3. Applicants can upload self-attested copies of a maximum of three Merit/Participation Sports Certificates.
- 4. The uploaded Merit/ Participation Sports Certificate will be evaluated as per the Criteria for marking of Merit/Participation Sports Certificate. However, the Marks obtained in the Highest uploaded Merit/ Participation Sports Certificate will be considered for preparation of the Centralized Sports Marks Award List.
- 5. Keeping in view the Covid19 pandemic situation, the Merit/Participation Sports Certificate of the preceding four years will be considered from 01st May 2017 to 30th April 2021.
- 6. The level of competency of the applicant will be determined only for those who have achieved distinction during the preceding four years in the Game/Sport at Point number II (B).
- 7. Applicant must secure a minimum of 10 marks in the marking of the uploaded Merit/Participation Sports Certificate to be eligible for admission on the basis of Sports.

- 1. The allotment of course to the eligible applicant shall be subject to fulfillment of course-specific minimum eligibility criteria and conforming to University regulations.
- 2. An applicant's name appearing in the Centralized Sports Marks Award List does not guarantee admission in a course and college. The admission of the applicant is subject to the availability of seats in a course and Game/Sport in the college.
- 3. The Sports Admission Committee of the College shall be as follows:
- i. Chairperson: Principal/Principal Nominee
- ii. Convener: Physical Education Teacher, Department of Physical Education
- iii. Member/s: Physical Education Teacher, Department of Physical Education
- iv. Nominee: One faculty member of the Staff Council
- 4. The Sports Admission Committee of the College shall:
- i. Screen the registration form uploaded by the applicant

ii. Verify the uploaded Merit/Participation Sports Certificates of the applicant as per the marks allotted from the original Merit/Participation Sports Certificate of the applicant.

## 5. In Case of Tie:

Applicants securing the same marks in the evaluated uploaded Merit/Participation Sports Certificate in the same Game/Sport and eligible for admission in the same course and same college may be resolved in the following order:

- a) The applicant securing higher marks in the best uploaded Merit / Participation Sports Certificate shall be considered for allotment/admission.
- b) If the applicants have the same marks in the best-uploaded Merit/ Participation Sports Certificate, the second-best uploaded Merit / Participation Sports Certificate shall be considered for allotment/admission to break the tie.
- c) If the applicants have the same marks in the second-best uploaded Merit/ Participation Sports Certificate, the third-best uploaded Merit / Participation Sports Certificate shall be considered for allotment/admission to break the tie.

In case the tie still persists then the tie-breaking rule adopted for admission to entrance-based courses will be adopted in the following order:

- i) The applicant with a higher percentage of marks (aggregate of best four subjects including one language) in the qualifying/board examination will be considered first for allotment/admission.
- ii) The applicant with a higher percentage of marks (aggregate of best five subjects including one language) in the qualifying/board examination will be considered first for allotment/admission.
- iii) The applicant with the earlier date of birth (as mentioned in class x certificate) will be considered first for allotment/admission.

If the Tie still persists, all such applicants may be admitted.

- 6. The grievance related to the award of marks of uploaded Merit/Participation Sports Certificate shall be redressed by the UG Sports Grievance Committee of the University. The marks of the uploaded Merit/Participation Sports Certificates shall be displayed on the dashboard of the applicant for three days to register grievances if any. All grievances shall be resolved within three days by the UG Sports Grievance Committee of the University.
- 7. The awarded marks displayed on the dashboard of the applicant are provisional subject to final scrutiny of the verification of uploaded Merit/Participation Sports Certificate/ documents by the UG Sports Grievance Committee of the University. The decision of the UG Sports Grievance Committee of the University shall be final.
- 8. The College shall maintain a proper record of the documents of the applicants admitted on the basis of Sports.
- 9. The list (soft copy) of finally admitted applicants on the basis of Sports shall be sent to the Dean, Admissions and Director, DUSC by the colleges within seven days of the last date of admission of the University.
- 10. An applicant, as per their age must be eligible to participate in Inter-University competitions for the next three years and should not be employed on a Part-time / Full-time basis anywhere.
- 11. The applicant must submit an Undertaking at the time of admission stating that the applicant will practice and participate for the College and if selected will represent the University in sports competitions as determined by College/University failing which the College has the right to cancel the admission if the applicant violates the Undertaking during their entire period of Undergraduate course of study.

### **Requirements for Admission**

## **Qualifying Examinations**

Qualifying examinations for the purpose of admission to the first year of undergraduate courses offered by the University of Delhi shall be Senior Secondary School Certificate Examination (Class XII) of the Central Board of Secondary Education or an examination recognized as equivalent thereto.

The applicants seeking admission to the undergraduate courses offered by the University should have passed the qualifying examination obtaining minimum marks as specified for each of the courses in subsequent sections.

### Age Requirement

As per Ordinance-I of the University, there is no minimum age bar for admission to the under- graduate and postgraduate courses in the University and its colleges except in the courses where the respective regulatory bodies, such as Medical Council of India (MCI), All India Council of Technical Education (AICTE), Bar Council of India (BCI), National Council for Teacher Education (NCTE), Dental Council of India (DCI), etc. have prescribed the minimum age requirement in their regulations.

### Gap year(s) will not be a bar for purposes of admission to the undergraduate courses.

## **Equivalence** Criteria

The applications for admission to the Undergraduate courses in the Colleges in respect of applicants belonging to the Examining bodies of Boards / Universities recognized / accredited by the Association of Indian University / University Grants Commission / Ministry of Education shall be considered by the College/Department in terms of the following recommendations as mentioned in the University circular letter of 13.01.2005.

That various degrees from Universities recognized by the Association of Indian Universities / University Grants Commission /All India Council of Technical Education (AICTE) /Council of Boards of School Education in India (COBSE) / Ministry of Education or by any bilateral agreement be considered as equivalent to corresponding degrees of the University of Delhi subject to the conditions that course duration is same as in the University of Delhi for purposes of determining eligibility for admission to various courses and further Departments/Colleges may be allowed to evolve procedure through their respective Admission Committees.

Senior School Certificate of various Boards recognized by Association of Indian Universities/Central Board of Secondary Education is considered as equivalent to the Senior School Certificate of Central Board for the purposes of eligibility to various Undergraduate courses.

Students who pass various Degree / School Examination of Foreign Universities / Boards as have already been approved by the Equivalence Committee, from time to time, be considered eligible as a matter of routine. The cases of only those applicants who do not fall in the list of Association of Indian Universities /University Grants Commission / All India Council of Technical Education (AICTE)/Council of Boards of School Education in India (COBSE) / Ministry of Education recognized accredited Boards/ Universities shall be referred to the University on the basis of individual merit.

Admission to any course shall not be granted on the basis of projected scores issued by any Board / School.

Further the University shall also treat the applicants passing the 10+2 exam from this board at par with the applicants passing 10+2 from other recognized boards and eligible for admission to UG courses of the University.

Further, the percentage uniform mark will be used by the University for admission purposes. Grades will not be converted to marks where percentage uniform marks are available.

In case any board declares the percentage marks of individual subjects along with the grades, then percentage marks shall be taken into consideration.

## **Rechecking/Revaluation**

The colleges shall consider admission of the applicants whose marks get increased in the process of rechecking/ revaluation by their respective boards within the prescribed period of admission provided that such applicant fulfills the other eligibility conditions laid down for ad- mission and seats are available in course/ college. The college will be required to update all the information on University Admission portal as per the University rules.

### List of Documents required at the time of Registration

The applicants shall be required to upload copies of the following certificates/documents at the time of registration and produce the documents in original at the time of physical verification at the end of the admissions process.

- 1. Class X Certificate (Mark-sheet or certificate) indicating date of birth and Parents' names\* (The names of applicants claiming reservation under SC/ST/OBC/EWS/CW/KM must match with the names that appear on the corresponding reservation certificates; similarly their parents' names must match in both sets of certificates).
- 2. Class XII Marksheet.
- 3. SC/ST/OBC/EWS/CW/KM Certificate (in the name of the Applicant) issued by the competent authority. (The names of applicants claiming reservation under SC/ST/OBC/EWS/CW/KM must match with the names that appear on their corresponding School Board qualifying certificates; similarly their parents' names must match in both sets of certificates).
- 4. OBC (Non-Creamy Layer) Certificate (in the name of the Applicant) issued by the competent authority, and wherein the caste is in the OBC central list issued by http://ncbc.nic.in. (The name of the applicant claiming reservation under OBC (Non-Creamy Layer) must match with the applicant's name as it appears on their corresponding School Board qualifying certificates; similarly their parents' names must match in both sets of certificates). Income certificate for the financial year 2020-21, dated on or after March 31, 2021, as stip- ulated, will be required. The format of the OBC certificate is as per the DOPT certificate issued in 2014. (Appendix VI)
- 5. EWS Certificate (Appendix V) from competent authority certifying the applicant can claim reservation under this category. (The names of applicants claiming reservation under this category must match with the names that appear on their corresponding School Board qualifying certificates; similarly their parents' names must match in both sets of certificates). Income certificate for the financial year 2020-21, dated on or after March 31, 2021, as stipulated, will be required.
- 6. Any applicants claiming admission through ECA/Sports categories must upload self- at- tested copies of the requisite certificates/produce the relevant required certificates when sought as stipulated in Section 6 of this Bulletin of Information.

Applicants shall be responsible for the quality and authenticity of the images they upload at the time of registration. Applicants must take care to ensure that uploads are authen- tic and accurate. Applicants will be responsible for production of documents as sought. All certificates/documents will be returned to the applicant by the College/Department upon completion of any physical verification that may be required at a later stage.

If the applicants do not have recent / valid EWS / OBC (Non-Creamy Layer) / SC or ST Caste / Tribe certificate at the time of Registration, the applicant may upload the acknowledgement slip of application for the certificate. However, at the time of admission, the applicant will have to produce his / her recent / valid original EWS / OBC (Non-Creamy Layer) / SC / ST certificate.

### **Admission Grievance Committees**

There will be a Central Admission Grievance Committee, located in the Dean Students' Welfare Office and a Grievance Committee in the Shyam Lal College. The names of College Grievance Committee Members are available in the College web site and also be displayed on the College Notice Board.

# IMPORTANT STUDENT RELATED INFORMATION IDENTITY CARD

Every student is issued an Identity Card by the college immediately after admission. He/she is expected to carry his/her identity card with him/her at all times. She/he will have to produce the same whenever required to do so by any member of the College staff in the college premises or outside or when he/she visits the college office for payment of fees or for any other purpose or when he/she goes to the College Library. If the identity card is lost, a fee of ₹ 50/- will be charged for issuing a duplicate card.

College Timings: 8 am to 3 pm.

### **ATTENDANCE REGULATIONS**

Every student must complete at least, two-thirds attendance of the total lectures/practicals held during the academic year to be eligible to appear in the University Examination failing which the students would not be allowed to appear in the examination. Students are governed by the rules and regulations laid down by the University in its Ordinance VII.

Parents/guardians are expected to know the status of attendance of their ward at the end of each semester. The students falling short of attendance at the end of each semester are notified by the College Students Attendance Committee.

### **UNIVERSITY EXAMINATION**

University of Delhi holds Examination/s for different courses for the final assessment of the students at the end of each semester. For details, students should regularly check the college notice board as well as college/University website.

Note: No student shall be deemed to have qualified for appearing in the University examination unless he/she fulfills the required attendance rules and other conditions.

### MIGRATION

- 1. As per University Rules, no migration is allowed in the first year.
- 2. Migration to the II year III Year from other Universities and Colleges may be allowed as per University Guidelines, subject to availability of seats and minimum percentage of marks as decided by the College.

### **DISCIPLINE OF THE COLLEGE**

(1) Students are expected to maintain a high standard of discipline and shall endeavor to promote the reputation of the Brand SLC and to inculcate camaraderie, mutual respect and healthy fellow feelings.

(2) Student against whom disciplinary action has been taken may not be granted re-admission. Such a student, apart from disciplinary action against him/her, will be liable to forfeit any prizes won or position held, if so, decided by the College Proctorial Board. The College has a very active Proctorial Board and presently Dr. Arkaja Goswami is the convenor of the Board. Students may contact the Proctorial Board for any kind of information, assistance and emergency. The college has also deployed a very active security agency and incase of any assistance or emergency, students may contact the security supervisor at his office near the college gate (All emergency/helpline numbers are displayed at the college gate).

## **CODE OF CONDUCT FOR STUDENTS**

- (1) Student shall refrain from;
  - (a) Misbehaviour towards members of the staff (teaching and administrative) and fellow students;
  - (b) Smoking, drinking, gambling and drug-taking in any form;
  - (c) Eve-teasing;
  - (d) Obstructing passage in the verandah;
  - (e) Causing damage to college building, furniture, fixtures, garden, canteen crockery, or to any other property;
  - (f) Making noise in or outside the class-rooms;
  - (g) Associating with outsiders to create indiscipline in any form in the college. No outsider will be allowed in the college without any expressed purpose and all visitors will have to make entry in the visitors register;
  - (h) Unauthorized entry in the college building on holidays;
  - (i) Unauthorized vehicle parking inside the College premises;
- (2) Students are liable to summary punishment for any of the offences listed at clause (a) to (i) above or any other behaviour considered as misconduct by the Proctorial Board.
- (3) Students are expected to be regular in their classes.
- (4) Students must keep the College neat and clean.
- (5) Students must observe complete silence in the Library and obey standing orders. They are expected to utilize the facilities properly.
- (6) Students may participate in their favorite games or sports, abiding by rules and regulations framed by the Sports Committee.
- (7) Students must always keep their Identity card with them, and produce it as and when asked for.
- (8) Students are advised to see the General Notice Board, the Sports Notice Board and the Library Notice Board as well as College website daily for obtaining up-to-date information of College notices/activities/programmes.
- (9) West Bengal Prevention of Defacement of Property Act has been promulgated in Delhi to keep the city clean. Punishment for contravention of its provisions is an imprisonment for a term of six months or a fine of ₹ 1000/ or both.
- (10) Students are expected not to invite any guest during the teaching hours in the College.
- (11) Suggestions from students are always welcome and will be given due attention.
  - The students are required fill up the undertaking to maintain the Code of Conduct as notified by the University of Delhi failing which they might be subjected to disciplinary action.
  - The Students are required to submit an online undertaking as regards prohibition of ragging by visiting the College website.

# Appendices

### Important Ordinances of the University of Delhi

Successful applicants will be required to abide by the Ordinances of the University and will be required to provide a written undertaking to this effect at the time of admission. A few extracts of important ordinances are reproduced here.

### **ORDINANCE XV-B:** Maintenance of discipline among Students in the University

- 1. All powers relating to discipline and disciplinary action are vested in the Principal.
- 2. The Principal may delegate all or such powers as he / she deems proper to the Proctorial Board and to such other persons as he may specify in this behalf.
- 3. Without prejudice to the generality of power to enforce discipline under the Ordinance the following shall amount to acts of gross indiscipline:
  - a. Physical assault, or threat to use physical force, against any member of the teaching and non-teaching staff and against any student of the College.
  - b. Carrying of, use of or threat to use of any weapons
  - c. Any violation of the provisions of the Civil Rights Protection Act, 1976
  - d. Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes
  - e. Any practice-whether verbal or otherwise-derogatory of women
  - f. Any attempt at bribing or corruption in any manner
  - g. Willful destruction of institutional property
  - h. Creating ill-will or intolerance on religious or communal grounds
  - i. Causing disruption in any manner of the academic functioning of the University system;
  - j. Prohibition of Ragging as per Ordinance XV-C.
- 4. Without prejudice to the generality of his / her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Principal, may in the exercise of his powers as per rules laid down by University of Delhi.

### **ORDINANCE XV-C:** Prohibition and Punishment for Ragging

- 1. Ragging in any form is strictly prohibited, within the premises of College as well as on public transport.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
- 3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students; and includes individual or collective acts or practices which:
  - a. Involve physical assault or threat to use of physical force.
  - b. Violate the status, dignity and honour of women students.
  - c. Violate the status, dignity and honour of students belonging to the scheduled caste and tribe.
  - d. Expose students to ridicule and contempt and affect their self-esteem. e.Entail verbal abuse and aggression, indecent gestures and obscene behavior.
- 4. The Principal of the College will take immediate action on any information of the occurrence of ragging.
- 5. Notwithstanding anything in Clause above, the Proctor may also suomoto enquire into any incident of ragging and make a report to the Principal of the identity of those who have engaged in ragging and the nature of the incident.
- 6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- 7. If the Proctorial Board is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/ she may so advise the Principal accordingly.
- 8. When the Principal is satisfied that it is not expedient to hold such an enquiry, his/ her decision shall be final.

- 9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under clause (7) disclosing the occurrence of ragging incidents described in Clause 3(a), (b) and (c), the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
- 10. The Principal may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a programme of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
- 11. In case any students who have obtained degrees or diplomas of the University of Delhi are found guilty; under this Ordinance, appropriate action will be taken under Statute 15 for withdrawal of degrees or diploma conferred by the University.
- 12. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice or incitement of ragging will also amount to ragging.
- 13. All Institutions within the Delhi University system shall be obligated to carry out instructions / directions issued under this Ordinance, and to give aid assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

Order of the Vice-Chancellor in pursuance of Ordinance XV-C: Where incident(s) of ragging are reported to the Vice-Chancellor by any authority under this Ordinance, the students(s) involved in ragging, shall be expelled for a specified term, designated in the order. Non-students involved in reports of ragging will be proceeded with under the criminal law of India; they will also be rendered ineligible for a period of five years from seeking enrolment in any of the institutions of the University of Delhi. Students against whom necessary action is taken under this note, will be given post decisional hearing, with strict adherence to the rules of natural justice.

# ORDINANCE XV-D/The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (MINISTRY OF LAW AND JUSTICE)

An Act to provide protection against sexual harassment of women at work place and for the prevention and redressal of complaints of sexual harassment and for matters connected there with incidental thereto.

WHEREAS sexual harassment results in violation of the fundamental rights of a woman to equality under articles 14 and 15 of the Constitution of India and her right to life and to live with dignity under article 21 of the Constitution and right to practice any profession or to carry on any occupation, trade or business which includes a right to a safe environment free from sexual harassment;

AND WHEREAS the protection against sexual harassment and the right to work with dignity are universally recognized human rights by international conventions and instruments such as Convention on the Elimination of all forms of discrimination against Women, which has been ratified on the 25th June, 1993 by the Government of India.

AND WHEREAS it is expedient to make provisions for giving effect to the said Convention for protection of women against sexual harassment at workplace. For details, please see the website

### Important Ordinances of the University of Delhi

Successful applicants will be required to abide by the Ordinances of the University and will be required to provide a written undertaking to this effect at the time of admission. A few extracts of important ordinances are reproduced here.

### **ORDINANCE XV-B:** Maintenance of discipline among Students in the College

- 1. All powers relating to discipline and disciplinary action are vested in the Principal.
- 2. The Principal may delegate all or such powers as he / she deems proper to the Proctorial Board and to such other persons as he may specify in this behalf.
- 3. Without prejudice to the generality of power to enforce discipline under the Ordinance the following shall amount to acts of gross indiscipline:

  - j. Prohibition of Ragging as per Ordinance XV-C.
- 4. Without prejudice to the generality of his / her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Principal, may in the exercise of his powers as per rules laid down by University of Delhi.

### **ORDINANCE XV-C:** Prohibition and Punishment for Ragging

- 1. Ragging in any form is strictly prohibited, within the premises of College as well as on public transport.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
- 3. - 6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- 7. If the Proctorial Board is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/ she may so advise the Principal accordingly.
- 8. When the Principal is satisfied that it is not expedient to hold such an enquiry, his/ her decision shall be final.

On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under clause (7) disclosing the occurrence of ragging incidents described in Clause 3(a), (b) and (c), the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.

- 13. All Institutions within the Delhi University system shall be obligated to carry out instructions / directions issued under this Ordinance, and to give aid assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

Order of the Vice-Chancellor in pursuance of Ordinance XV-C: Where incident(s) of ragging are reported to the Vice-Chancellor by any authority under this Ordinance, the students(s) involved in ragging, shall be expelled for a specified term, designated in the order. Non-students involved in reports of ragging will be proceeded with under the criminal law of India; they will also be rendered ineligible for a period of five years from seeking enrolment in any of the institutions of the University of Delhi. Students against whom necessary action is taken under this note, will be given post decisional hearing, with strict adherence to the rules of natural justice.

# ORDINANCE XV-D/The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (MINISTRY OF LAWAND JUSTICE)

An Act to provide protection against sexual harassment of women at work place and for the prevention and redressal of complaints of sexual harassment and for matters connected there with incidental thereto.

# **Frequently Asked Questions**

- Q. I have registered online on the DU undergraduate (UG) online portal. Do I still need to fill any offline form for undergraduate admission?
- A. There is no offline form for DU undergraduate admissions. You need to register and fill up the online form, available on the centralized online Admission Portal of the University, where a candidate can apply for both courses where admission is based on merit in Class XII qualifying examinations, as well as courses where admission is based on entrance tests.
- Q. What are the courses I can apply for using the online form?
- A. The following are the courses which applicants may submit applications for using the on- line registration form:

### **Courses to which Admission is based on Entrance Test:**

- Q. Is there a way to apply for admission offline?
- A. No, there's no offline form/method. You have to apply through the centralized online Ad-mission Portal http://admission.du.ac.in/.
- Q. What should I do if I filled an incorrect email address while registering?
- A. You have to register again with the correct email address to fill the registration form.
- Q. Can I register in multiple courses in an online form?
- A. You can register in multiple courses by choosing all the courses that you wish to apply through a single online registration form.
- Q. Can I apply for undergraduate course based on entrance tests through this form?
- A. Yes, applicants can apply for undergraduate courses based on entrance tests through this portal.
- Q. Do I need to fill separate forms for applying to different colleges?
- A. No, one single form submits your registration and application for admission to the various colleges (except St. Stephens and Jesus & Mary College) of the University of Delhi.

- Q. I am also interested in applying to minority colleges, how can I apply?
- A. You would get an option to complete their registration form separately after applying through DU portal, It is mandatory for the candidates who wish to apply to minority colleges (Christian) to mention the university registration number generated through the online registration process.
- Q. Which are the mandatory fields in the application?
- A. Mandatory fields are indicated by a red star asterisk (\*) adjacent to the titles of the fields. The applicant must fill the relevant information in these fields to complete the registration.
- Q. I made an error in filling my online registration form. Do I register again using differ- ent email id and fill the new registration form?
- A. No, the portal does not allow you to register twice. However, you can rectify your error by again logging into your account, and using the "Edit" button at the end of each session/page. You can do this till you click on the "Payment" link to pay the fee and thus submit your registration form. After you have submitted your form, you may only make a one-time correction for some limited types of information, for a fee of Rs. 100.
- Q. In online portal, I have created my account and filled my registration form. Can I use the same account to fill the registration form for my friend?
- A. No, only a single applicant can apply from one account for UG Admissions. Each applicant/candidate must create a separate account and fill the separate online registration form.
- Q. I do not have an email account. Can I use someone else's email to create registration account during "Sign Up"?
- A. No, you should not use anyone else's email account for registration. You must create a valid email account and remember its password, as all the communication from the University would be sent to your email account used during the admissions process.
- Q. I forgot the email account that I created to use during my registration process. What should I do?
- A. Your email address will be your login id during the registration process. It is absolutely necessary that you remember your email address, without which we will not be able to help you.
- Q. How can Persons with Benchmark Disabilities (PwBD) access and fill the online application form?
- A. The PwBD applicants may fill the online application form by using assistive technology. In particular, the visually impaired applicants may use screen reading softwares such as JAWS or NVDA to complete the application form. Those unable to use computer may take human assistance.
- Q. What should be done if the University website link hangs or becomes non-functional during the process?
  A. All possible measures are taken during the development phase to avoid such a situation. However, such a problem may arise due to Internet issues or if a large number of applicants access the site simultaneously. The registration form has a "Save and Continue" feature, which you may use if you are not able to complete the entire form in one session. You are advised to click on the "Submit" button on each page/session separately to save the information, and you may proceed with filling up of the remaining online registration form after refreshing the link or logging into your account in another session. You are also advised not to wait till the last day to complete or submit the form.
- Q. How can I pay the registration fee on DU UG Portal?
- A. Payment is accepted online only through Credit card/Debit card/Net Banking/UPI. Make sure that you pay only through the payment link provided in the Admissions Portal.

- Q. Can I get a fee concession? What is the procedure for fee concession?
- A. All applicants have to pay the registration fee as specified in Section 1 of the UG Admis- sions Bulletin 2020-21. There is a provision for fee concession in most of the colleges but only after admission. You are advised to contact the college for details.
- Q. During online payment, the amount has been deducted from my account but I am still seeing the status "pending" on the UG admission portal.
- A. A detailed resolution pathway for dealing with technical issues related to online payment will be provided as an Annexure (to be updated on the University Website) to the Undergradu- ate Admissions Bulletin 2020-21. You may approach the numbers and emails listed there with complete details of the transaction under "Grievance Description". Resolution of queries of this nature will be taken up on the priority basis.
- Q. Will the applicants be given admission on a first-come, first serve policy after decla- ration of cut-offs?
- A. Admissions in the colleges are not based on first come first serve policy. Instead, the applicant who has filled the online registration form and satisfies the criteria and cut-off for a particular course in a particular college will be considered for admission as per the schedule of admission specified.
- Q. I am a science student. Can I apply for Bachelor with Honours in Arts/Humanities subjects?
- A. Yes, provided you fulfill the course-specific eligibility conditions and meet the requisite cut- off for the course you wish to seek admission to. Refer to Sections 2 and 3 of the Undergraduate Bulletin of Information 2020-21 for more information.
- Q. Once I have taken admission in a particular subject, can I change my subject during the course of study or after completing first year?
- A. Once you are admitted in a particular subject, you can change your subject only before the last date of admission provided you have applied for that course in your online registration form, meet the requisite cut-off and provided seats are available. You cannot change your subject during the course of study or after completing the first year of your study.
- Q. I appeared in the class XII exam last year but failed to clear Mathematics. Then, I appeared in the compartment exam and cleared it. Now, I have two marksheets, can I get admission?
- A. Yes, you can get admission in the University of Delhi provided result of compartment exam is declared before the admission process is completed and seats are available. You are sup- posed to update the online registration form by filling your latest marks, possible till the end of admissions, while the registration portal is open.
- Q. I have just passed class XII with science subjects. I want to apply to Delhi Uni-versity colleges including St. Stephens and Jesus Mary College. Can I apply in through the online form?
- A. The online registration form is applicable for all merit-based courses in various colleges. For applying to minority colleges like St. Stephens and Jesus and Mary, you will need to visit the portal of these colleges to fill their registration form separately. However, it is mandatory for those applicants who wish to apply to minority colleges to enter the university registration number in the online form of the minority colleges. These colleges shall follow the admission procedures notified well in advance on their websites.
- Q. Can I submit the online registration form, even if my result is awaited?
- A. Yes, you can submit the online registration form by choosing "Awaited" in the drop-down menu of "Result Status" on the "Academic Details" page/section while entering the information. However, you will have to fulfill the minimum eligibility criteria and meet the college- and course- specific cut-off list during the stipulated period.

- Q. Can I fill in the online registration form even if I have a compartment in class XII?
- A. You can fill in the online registration form using the "Awaited" option for "Result Status" if you have submitted your marks for re-evaluation or if you have appeared again for the paper(s) that you have not passed in. Once your updated marks appear, you may update the Registration Portal. However, your registration form will be valid only if you update your marks within the admission period, and if you fulfill the course-specific eligibility criteria, meeting the cut-off marks for that course/college and subject to the availability of seats.
- Q. Will registration fee be refunded or adjusted if I change my category?
- A. The registration fee is mandatory for all categories and will not be refunded or adjusted in any circumstances.
- Q. Why am I not able to preview my application and also not able to pay the fee?
- A. Please ensure that you have:
  - i) Completed the mandatory fields (marked with red asterisk) on every page.
  - ii) You have uploaded the required documents under "Mandatory Uploads."
- Q. Can I register for multiple courses in one online form?
- A. Yes, you may select all courses of interest to you through a single online registration form.
- Q. Is it possible to change/update the information provided by the applicant in the online application form once the fee is submitted?
- A. No. Applicants cannot change/update the information after they submit the registration fee.
- Q. I belong to ST category and live in a remote place. How can I apply for undergraduate courses in your University?
- A. You can apply online by filling the registration form from any location with Internet access.
- Q. Is it important to have caste or tribe certificate in the name of the applicant?
- A. Yes, if you are applying under any reserved category, then you must have the relevant reservation certificate issued by the competent authority, in the name of applicant. The OBC certificate must also specify that applicant belongs to non-creamy layer and the caste is listed in the Central Government list.
- Q. Will there be any disadvantage for gap year students?
- A. No, there is no disadvantage to gap year students and they will be treated at par with regular students. They should meet the requisite course-specific criteria for admission and must possess the necessary documents/certificates.
- Q. I did not have Mathematics in Class XII. Can I opt for Economics (Hons.) or B.Com. (Hons.)?
- A. No, you cannot opt for Economics (Hons.) or B. Com. (Hons.) without having studied Mathematics in Class XII.
- Q. Is the applicant/ candidate required to be present in-person to take admission once the cut-off is announced?
- A. No, the applicant is not required to be present in-person to take admission once the cut-off is required. But the applicant must ensure that he/ she fulfils the eligibility criteria, fall in the required cut-off and has paid the fees once his/ her admission has been approved.

- Q. Can I take admission in two different courses or the same course in different colleges after declaration of a cut off?
- A. No, you cannot take admission simultaneously in two different courses or the same course in different colleges. In case you take admission at two places, your admission will be cancelled from both the colleges/courses.
- Q. I was admitted under Sports Quota last year but could not clear the first year. Can I apply afresh and also change my course?
- A. You can clear your first year as an ex-student, if your internal assessment is complete (including attendance). In case you wish to apply afresh for another course, you can do so by cancelling your previous admission and then filling the online registration form again.
- Q. I have completed my class XII from NIOS (National Institute of Open Schooling). Can I get admission in a regular college?
- A. Yes, you can get admission in a regular college in a particular course provided you have applied in that course and meet the cut-off criteria.
- Q. Can I enroll myself for a certificate language course along with my regular graduation course?
- A. Yes, many colleges offer part time certificate courses in office management, foreign languages etc. However, it is advisable to first try to understand how your regular course works, how much free time you have, and then plan your certificate course accordingly.
- Q. Can an applicant for an Undergraduate Honours Course be considered for admission in the non-Honours Course in the same College or not?
- A. Applicants are required to select in the online registration form all those courses in which they intend to apply for admission. Admission shall be considered w.r.t. the courses applied in the filled online registration form. If you satisfy the course-specific eligibility and meet the cut-off mark requirements within the duration specified, you may be considered for non-Honours and Honours courses that you applied for through your online registration form.
- Q. What is the mechanism of fee refund in case a student cancels his admission?
- A. You may examine the relevant Annexure (to be updated) of the Bulletin of Information for Undergraduate Admissions 2020-21 to know the rules thereon.
- Q. Is ECA and Sports quota applicable to courses where admission is based on en-trance tests?
- A. No, ECA and Sports quota are not applicable to courses where admission is based on entrance-test.
- Q. How does one apply through the ECA or Sports quota? Is there a separate fee for applying to these quotas?
- A. You can apply for the ECA and Sports quota by selecting appropriate options in registration form. There is an additional fee of Rs. 100 each for applying under ECA or Sports quota, i.e. if an applicant applies for both ECA and Sports quota, it would amount to Rs. 200 in addition to registration fee of the form.
- Q. How many certificates must I furnish for admission through Sports Quota?
- A. You may upload for a maximum of three categories of Games/Sports. You may attach a maximum of three of your Best/ Scoring/Highest Certificates for each game/sport that you think is the best scoring. You may refer to section 6.2 of the bulletin for detailed information.
- Q. How many certificates must I furnish for admission through ECA Quota?
- A. You may upload a maximum of five certificates. issued between 1st may 2017 to 30th April 2020. You may refer to section 6.1 for detailed information.

- Q. Will there be a centralized sports trial?
- A. The policy of the sports trial will be notified on the University of Delhi website considering the situation in the wake of COVID 2019.
- Q. Is it possible to apply under ECA/Sports Category once I have paid my registration fee?
- A. No, once you have paid the fee, you will not be able to apply under ECA/Sports Category.
- Q. Does the University of Delhi offer hostel facilities?
- A. Yes, there are a few colleges of the University that offer hostel facilities to the students. The list of such colleges with details of the selection process is given in the relevant Annexure of the Bulletin of Information for Undergraduate Admissions 2020-21.
- Q. What is the procedure for getting hostel accommodations?
- A. The selection process for hostels is strictly based on the merit of the candidate. Once a candidate gets admission in a college offering hostel facility then, they have to apply separately for hostels; accommodation is subject to availability of seats.
- Q. Does the University of Delhi follow any policy with regard to ragging and sexual harassment?
- A. Yes, the University believes in providing a safe and secure environment to all entrants. We adhere to the UGC guidelines, 2009 regarding curbing the menace of ragging and to ordinance XV-B of the University related to anti-ragging, in addition to following the provisions outlined in the Sexual Harassment of Women at the Workplace (Prevention, Prohibition and Redressal) Act 2013.
